## Jury Finds Shaiquan Reeves Guilty of Robbery in the 1<sup>st</sup> Degree and Various Violent Felony Offenses for a Car-Jacking and Shooting

Rochester, NY- Monday, August 4, 2025, a Monroe County Jury convicted 26-year-old Shaiquan Reeves of all seven counts in the indictment, including Robbery in the 1<sup>st</sup> Degree, two counts of Robbery in the 2<sup>nd</sup> Degree, two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, Grand Larceny in the 4<sup>th</sup> Degree, and Assault in the 2<sup>nd</sup> Degree for a car-jacking and subsequent shooting of a 61-year-old woman in the City of Rochester.

On October 5, 2024, Shaiquan Reeves stole a running, unattended car near Tremont Street in the City of Rochester. The lawful owner of the car attempted to retrieve his stolen vehicle. As the confrontation began, Shaiquan Reeves fired multiple bullets from an illegally possessed, loaded pistol in an attempt to keep the stolen vehicle. One of those fired shots struck an unarmed 61-year-old woman in both legs. The victim required hospitalization at Strong Memorial Hospital.

After a thorough investigation by the Non-Fatal Shooting Taskforce, which includes Rochester Police Investigators, Monroe County District Attorney Investigators, and Assistant District Attorneys, it was determined that Shaiquan Reeves stole the vehicle and shot the second victim.

The case was prosecuted by Special Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Taskforce.

"Today's conviction is a much-needed resolution to the victims in this case, especially to the woman whose life was permanently altered by this senseless act of violence," said Assistant District Attorney Anthony Freeman. "I want to thank the Rochester Police Department, the Monroe County Crime Laboratory, and our exceptional Non-Fatal Shooting Taskforce members, including DA Investigators Christopher Picha and Ignacio Torres, and Victim/Witness Advocate Sabrina LaMar. Their relentless work and collaboration made this outcome possible. This case is a clear example of how coordinated, detailed investigations lead to meaningful accountability."

"This shooting is reminder of how a stolen car can escalate to violence and gunfire," said District Attorney Sandra Doorley. "Today's conviction is a direct result of the Non-Fatal Shooting Initiative, which has strengthened our ability to support victims and earn the trust of witnesses. We are grateful the victim has largely recovered, but we know the physical and emotional scars of shootings can last a lifetime. Our mission is to continue building a safer community by ensuring that violent offenders like Shaiquan Reeves are held fully accountable and removed from our streets."

Shaiquan Reeves will be sentenced on September 10, 2025, in front of New York State Supreme Court Justice Renzi.
