This informational newsletter will provide periodic updates (as needed) on the status of the Highway Preventive Maintenance #10 Project and communicate upcoming construction activities to local residents.

**CURRENT PROJECT STATUS**

**SCHEDULE UPDATE FOR WORK ON SOUTH WINTON ROAD AND ON BRIGHTON-HENRIETTA TOWNLINEROAD**

The contractor has been working diligently the last few weeks to adjust drainage grates and to replace sidewalk ramps, curbs, and gutters in preparation for milling/paving operations on South Winton Road. The current schedule (weather dependent) is as follows:

- Week of 5/28 to 5/31 - mill between Westfall Road and Cambridge Place (north of I-590) and between French Road and Brighton-Henrietta Townline Road (south of I-590)
- \*\*Friday 5/31 (starting at 9:00pm) to Monday 6/3 (at 6:00am) - **a complete closure of South Winton Road (including the on and off-ramps to/from I-590)** will be installed in order to mill and re-pave the “diverging diamond” interchange at South Winton Road / I-590. Portable Electronic Message Boards will be installed prior to the closure to alert motorists and detour signs will be posted.
- Week of 6/3 to 6/7 - re-pave the remaining milled areas on South Winton Road.

(\*note: if weather forces cancellation of the planned closure on 5/31, the make-up dates for the closure will be 6/7 to 6/10)

In addition to the work on South Winton Road, the contractor has also begun operations on Brighton-Henrietta Towline Road (beginning at S Winton Road and progressing to the west). Work that is currently underway involves adjusting drainage grates and to replacing sidewalk ramps, and rehabilitation of the culvert located just west of Canal View Blvd. Milling on Brighton-Henrietta Townline Road is tentatively scheduled to begin in early July.
