### **COVID-19** Testing in Monroe County

- 1,168 test results have been received to date
- 68 positive results, 1,100 negative results

This information includes all testing by physicians, health care facilities and licensed clinical laboratories in Monroe County and will be updated every day at 4 p.m.

### **Confirmed Cases**

There are 68 confirmed cases of COVID-19 in Monroe County.

#### New Cases

There are 5 new confirmed cases of COVID-19 since today's 10 a.m. update. The new individuals include:

- 1 Female in her 30s
- 1 Female in her 40s
- 1 Male in his 60s
- 1 Female in her 60s
- 1 Female in her 70s

### Hospitalized patients

Of the 68 confirmed cases, 11 people are hospitalized. Beginning today, we will also report the number of hospitalized patients who are in ICU: 6 of the 11 patients are in ICU.

### **Deaths related to COVID-19**

1 patient

### **Mandatory Quarantine**

The Health Department has placed 289 people into mandatory quarantine and isolation.

### IMPORTANT REMINDER ABOUT TESTING FOR COVID-19.

There are a limited number of COVID-19 tests available in Monroe County and not everyone with potential symptoms of COVID-19 can be tested.

For most people, the results of a test for COVID-19 will have no impact on what happens next. Everyone should already be staying home, practicing social distancing, and talking with their healthcare providers to manage any symptoms. Having a positive test result does not change this guidance.

The tests are reserved for individuals for whom test results will have an impact on what happens next. For example:

- A healthcare worker or first responder who tests negative can return to work more quickly.
- A hospitalized patient who tests negative can be removed from isolation, which saves PPE usage.
- A hospitalized patient who tests positive will receive more targeted treatment.
