### **Weekly Adjustment to Total Number of Cases To-Date**

The total number of COVID-19 cases to-date is 5092. This reset reflects the removal of previously reported new cases that investigators determined were duplicates or out-of-county cases, or the addition of new cases that were initially reported in counties other than Monroe County. This adjustment will be made every Monday. (Previously, the reset occurred on the date a discrepancy was identified.)

## **Deaths**

## **Hospitalized**

*Beginning today, we will report the hospitalization data as a region instead of Monroe County specific. The ICU date includes patients who are not on ventilators as well as patients who are on ventilators.*

28 people in the Finger Lakes Region are hospitalized, 8 of them are in ICU

## **Recovered from Isolation**

There have been 4462 Recovered from Isolation – Confirmed cases to date.

There have been 4783 total Recovered from Isolation to date. This number reflects confirmed positive COVID-19 cases and known presumed positive COVID-19 cases.

## **Testing**

The 3-day average of daily total test taken in Monroe County is currently at 1448 tests per day (PCR). There have been 148,393 total PCR tests received to date in Monroe County.
