**Statement from Dr. Michael Mendoza, Commissioner of the Monroe County Department of Public Health:** *Today's increase in positive cases of COVID-19 is greater than we have experienced in some time. My team and I are working through the evening to continue contact tracing of these cases. At this point, the increase appears to be partially due to a series of micro-clusters within close-knit communities, as well as the cluster at St. John Fisher College. I understand that many of us are experiencing pandemic fatigue, but we must continue to take precautions that protect the health and safety of our entire community.*

## **Recovered from Isolation**

There have been 5662 Recovered from Isolation – Confirmed cases to date.

There have been 5983 total Recovered from Isolation to date. This number reflects confirmed positive COVID-19 cases and known presumed positive COVID-19 cases.

## **Testing**

The 3-day average of daily total test taken in Monroe County is currently at 1218 tests per day (PCR). There have been 219,949 total PCR tests received to date in Monroe County.
