REMINDER: There is typically a discrepancy between the total number of cases reported by Monroe County and the total number of cases reported by New York State. There are several reasons for this discrepancy, but it is largely due to two factors: 1) the time of day the reports are pulled differs and 2) many cases assigned to Monroe County by New York State are actually individuals who were tested in Monroe County, but live in another county. Monroe County forwards these cases to the other counties and resets the total number of cases every Monday.

Total Number of Cases To-Date

The total number of COVID-19 cases to-date is 8507.

7-Day Rolling Average Positivity Rate

The 7-day rolling average positivity rate for Monroe County is 3.63%

New Cases and 7-Day Rolling Average of New Cases

There are 148 new confirmed cases of COVID-19 since the last update. The 7-day rolling average of new cases is 158 new cases per day.

Deaths

There were 0 new deaths. The total is 307 to date.

Hospitalized

129 people in the Finger Lakes Region are hospitalized, 22 of them are in ICU

Recovered from Isolation

There have been 6934 Recovered from Isolation – Confirmed cases to date.

There have been 7255 total Recovered from Isolation to date. This number reflects confirmed positive COVID-19 cases and known presumed positive COVID-19 cases.

Testing

The 3-day average of daily total test taken in Monroe County is currently at 1585 tests per day (PCR). There have been 249,974 total PCR tests received to date in Monroe County.

REMINDER: *There is a discrepancy between the number of tests reported by Monroe County and the number of tests reported by New York State. This is due to the fact that the Monroe County system counts each person tested, while the New York State system counts every test taken. For example, a health care worker who gets tested each week is counted once by Monroe County, and multiple times by New York State.*
