- Individuals who are 65 years or older are now eligible for the COVID-19 vaccination. Gov. Andrew Cuomo has indicated that, due to vaccine availability, it could take 14 weeks for eligible individuals to schedule an appointment. Please check back daily for instructions on how to schedule an appointment as vaccine becomes available.
- EMS workers who are due for their second dose of the vaccine beginning Jan. 25 may now schedule an appointment using the link provided by their EMS agency.
- The Monroe County Department of Public Health has no vaccination openings at this time. If you are a Phase 1A or 1B eligible resident and have not already scheduled an appointment, please check back daily for updates.
- If you are 75 years or older, your health care provider will contact you to schedule a vaccination appointment. Select Wegmans pharmacies will also be scheduling appointments for individuals 75 years or older only. Other options could become available soon, so please check back for updates.

7-Day Rolling Average Positivity Rate

The 7-day rolling average positivity rate for Monroe County is 9%.

New Cases and 7-Day Rolling Average of New Cases

There are 509 new confirmed cases of COVID-19 since the last update. The 7-day rolling average of new cases is 620 new cases per day.
