Total Number of Positive Cases To Date in Monroe County

The total number of positive cases to date in Monroe County is 72096.

7-Day Rolling Average Positivity Rate

The 7-day rolling average positivity rate for Monroe County, based on combined NAAT/PCR and Antigen test results (NYS), is 4.4%. The 7-day rolling average positivity rate based on NAAT test results (CDC) is 6.08% (Moderate).

Case Rate per/100K Over Last 7 days (CDC)

The case rate per/100K over the last 7 days was 138.18 (High)

New Cases from the Past Week and 7-Day Rolling Average of New Cases

There were 149 new confirmed cases of COVID-19 today. There were 1175 new cases reported since Monday, August 23. The 7-day rolling average of new cases is 168 new cases per day.

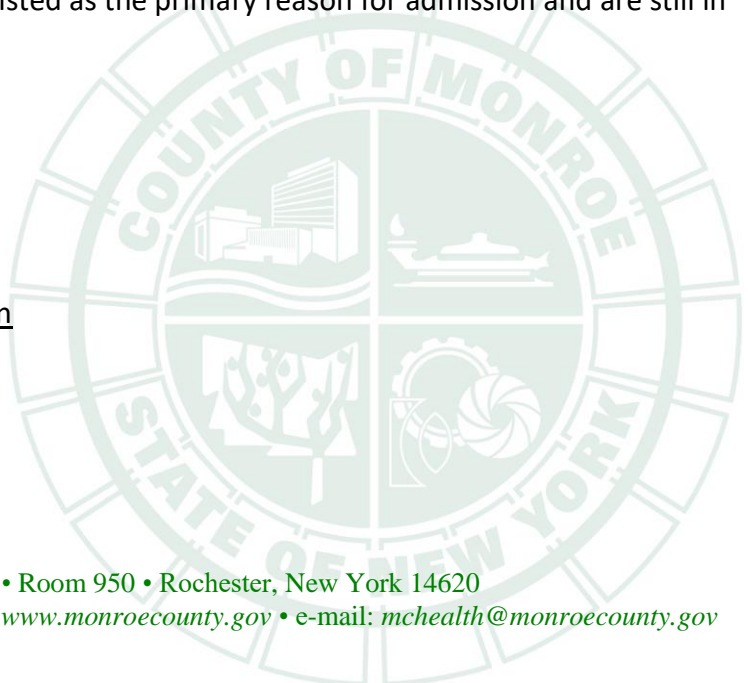
