Hospitalization

502 individuals are hospitalized for COVID-19 in the Finger Lakes Region (down 2 since previous day). 125 of these patients are in ICU (no change since previous day).

Total Number of Positive Cases To Date in Monroe County

The total number of positive cases to date in Monroe County is 102375.

7-Day Rolling Average Positivity Rate

The 7-day rolling average positivity rate for Monroe County, based on combined NAAT/PCR and Antigen test results (NYS), is 7.9%.

New Cases from the Past Week and 7-Day Rolling Average of New Cases

There were 248 new laboratory-confirmed cases of COVID-19 today. (Home test results unavailable today.) There were 3632 new cases reported since Monday, December 6, 2021. The 7-day rolling average of new cases is 519 new cases per day.

Saturday 12/11: 434 new laboratory-confirmed cases of COVID-19 reported, 49 positive home tests reported

Sunday 12/12: 302 new laboratory-confirmed cases of COVID-19 reported, 41 positive home tests reported

Reported Deaths

23 new deaths were reported. Dates of death: 11/21/21 – 12/9/21. The total is 1529 to date.

Deaths Due to COVID in Monroe County – Percent Not Fully Vaccinated

Between March 1, 2021 and December 13, 2021, a total of 291 deaths were reported. Among patients under the age of 65, 91% were not fully vaccinated. Among patients ages 65 and older, 66% were not fully vaccinated.
