The 7-day rolling average positivity rate for Monroe County, based on combined NAAT/PCR and Antigen test results (NYS), is 8.9%.

Please Note: Due to the holiday, there is a significant delay in reporting of test results. It is likely that today's numbers do not accurately reflect the total number of new cases, which will be included in reports later this week. There were 232 new laboratory-confirmed cases of COVID-19 today. There was 1 new positive home test reported today.

There were 3750 new cases reported since Monday, December 20, 2021. The 7-day rolling average of new cases is 536 new cases per day.
