Meeting Topic(s):

Overview of the Environmental Management Council (EMC) Tom Dooley, EMC Chairperson

- Monroe County Environmental Management Council established in 1971 under Monroe County Charter, as per charge of Environmental Conservation Law (ECL), Article 47
- EMC Mission The EMC is an agency composed of an environmentally focused professional staff and an appointed non-partisan volunteer citizen group. The EMC recommends and implements solutions and advises and informs the government and community on the conservation, protection and use of the environment. This is done for the benefit and enjoyment of the present and future inhabitants of Monroe County.
- Membership consists of representatives from municipal conservation boards, members at large, and representatives from county departments and legislature.
 - Drop in membership and attendance due to COVID-19, but starting to increase again
 - The EMC has focused on regaining membership participation, finalizing letter to legislature and annual report
 - Looking at possibility of student members
- In 2023, decided to rejuvenate Council and rebuild go back to basics, as per the EMC Rules of
 operation and ECL Article 47
 - Two standing committees Presentation and Nominating
 - One Ad Hoc Natural Resources; to meet requirement of natural resources inventory
 - Trying to determine what was done in the past
 - Meeting with GIS for way forward
 - Developed workplan for 2024
- Role of municipal representatives Comprehensive plans, 100-acre plan assessments, SEQR

Overview of the Recycling Advisory Committee (RAC) Jeff Meyers, RAC Chairperson

- Introduction
 - General Manager for Cascade Recovery, representing the side of the waste haulers on the RAC
 - o RAC Chair
- RAC grew out of the law that created the curbside recycling program
 - Membership includes education representative and business alliance representative
- Conduct about 2 tours per year at meetings
- RAC involvement over the last year
 - Food waste (impact earth, Foodlink tour)
 - o Sustainability plans
 - o Material handling (economic impact on waste haulers)
 - Insulation recycled fiber
 - County transfer station
 - Extended Producer Responsibility (EPR) = funding for recycling and disposal of the material and packaging

- Monroe County Department of Environmental Services
 - o Over 300 employees
 - o Many Divisions
 - Fleet Center
 - Engineering
 - Facilities Management
 - Pure Waters
 - GIS
 - Solid waste management
- In 1972, there were about 40 wastewater facilities in Monroe County.
 - o In 1967, Pure Waters was formed
 - Shut down local facilities that mostly only had primary treatment
 - Made regional facilities that had both primary and secondary treatment
 - Four Pure waters districts were developed.
- Resource Conservation and Recovery Act (RCRA), is a federal law governing the disposal of solid waste and hazardous waste. At the time it was enacted, there were over 40 solid waste sites in the County.
- EcoPark Overview
 - o 439,500 residential customers
 - Over 300 businesses served in 2023 (Business waste)
 - o EcoPark Ask a Question <u>www.monroecounty.gov/des-recycle-question</u>
- EcoPark collections
 - Total annual weight of recycled scrap metal, cardboard, bulky plastics, etc. has been increasing over the years – 2023 was record year
 - Additional materials collected include propane tanks, cooking oil, sharps/syringes, plastic bags, rechargeable batteries, tires, Freon devices, US flags, printer cartridges, and shredded paper.
 - Tires do still have \$5 charge to turn in. Generally turned into crumb rubber and often made into traffic cones
 - US Flags are sent for a retirement ceremony at Covanta for disposal
 - New York State Electronics Equipment Recycling & Reuse Act enacted January 2023; mandates that electronics manufacturers provide free and convenient recycling of electronic waste.
 - No longer a charge to dispose of CRT TVs
 - 3,640 tons of electronics collected (Sunnking is electronics handler)
 - EcoPark mobile collections Wegmans, Town of Clarkson, Town of Mendon.
 - Home hazardous waste collection locations Chili/Gates, Perinton, Hilton, Webster, & Irondequoit.
 - PaintCare recycling to diver paint from the solid waste stream. Fees are added when buying paint. No charge when turning in to recycle. Many local hardware accept used paint for recycling

- Vape/e-cigarette takeback program disposal of devices containing lithium ion battery and hazardous wastes.
- Pharmaceutical takeback approved pharmaceuticals can be collected and disposed of at designated locations including local police stations.
 - New York State Drug Takeback Act mandates that pharmaceutical manufacturers establish, fund, and manage an approved drug takeback program for safe collection and disposal of unused covered drugs.
 - DEA drug takeback days (last Saturday of April and October).
 - Around 15,000 pounds of pharmaceuticals collected in 2023 at PDs.
 - New York State has partnered with companies Inmar and MED-Project for pharmaceutical takeback.

- Textiles are provided to Goodwill. Items are sorted:
 - If in good shape Sold for resale at Goodwill stores
 - If not sent to Goodwill Clearance Center and sold by the pound
 - Any materials not sold are baled and sold
 - Ultimate goal is textile recycling
- Recycling Education
 - WHEN IN DOUBT, THROW IT OUT
