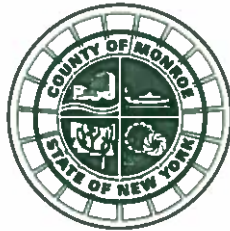

LEGAL NOTICE

ABSTRACT OF LOCAL LAW NO. 2 OF 2021, ENTITLED "PHARMACIES TO PROVIDE NOTICE ON THE AVAILABILITY OF NALOXONE" ADOPTED BY THE MONROE COUNTY LEGISLATURE ON FEBRUARY 9, 2021, AND APPROVED BY THE COUNTY EXECUTIVE ON MARCH 10, 2021.

This proposed legislation would require pharmacies in Monroe County to provide notice of the availability of Naloxone whenever they first fill an opioid prescription for a customer, whenever there is a change to a customer's opioid prescription, or whenever they next fill an opioid prescription for a customer after the effective date of the proposed local law.
