Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to

Establish Permanent Airport Capital Funding Programs in the State Budget

Honorable Legislators:

The Greater Rochester International Airport (ROC) was the first airport statewide to win Governor Andrew Cuomo's Upstate Airport Economic and Revitalization Competition. Monroe County received a \$40 million grant from New York State for renovations and upgrades to the Airport. The project was completed in October 2018 and has transformed the Airport into a safer and more modern facility that travelers can enjoy and Monroe County residents can be proud of. This grant was critical in providing visitors with a positive travel experience, supporting local jobs, and bringing a 21st century Airport to Monroe County.

According to the New York State Department of Transportation and the Port Authority of NY-NJ, the aviation industry is responsible for over \$72 billion in annual economic activity and more than 500,000 jobs in New York State. The aviation industry also generates more than \$25 billion in payroll and over \$6 billion in state and local tax revenue every year. Investments and upgrades to existing airports in New York must continue in order to preserve the economic and employment benefits that airports bring to our communities.

The Upstate Airport Economic and Revitalization Competition awarded funding to six airports for upgrades to security, operations, access, and passenger experience. While many airports across New York State are still in need of financial assistance for improvements, the Competition has distributed all available funding and the State has no dedicated source of revenue or permanent capital program for airports. In addition, the 2018-19 State Budget has allocated only \$12.5 million for the Aviation Capital Grant Program for the next two fiscal years which is a reduction of \$10 million from the two previous fiscal years. Reliable funding for Airport improvements is necessary to ensure that the aviation industry in New York remains competitive and successful.

Therefore, I urge you to join me in calling on the New York State Legislature and Governor Andrew M. Cuomo to authorize additional funding for the Aviation Capital Grant Program and authorize a new round of funding for the Upstate Airport Economic and Revitalization Competition. This funding will support important airport rehabilitation projects that will support jobs, improve airports, and invest in the upstate economy.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Greater Rochester Housing Partnership, Inc., Monroe 1 BOCES, Monroe 2 Orleans BOCES, and contractor selected by BOCES and Greater Rochester Housing Partnership, Inc. for the acceptance of pre-fabricated house(s) to be relocated to real property owned by Monroe County for hands-on-construction trades training pursuant to the Make Monroe Home Program.

Monroe County will identify distressed, vacant, property it owns through the real estate tax foreclosure process and has been unsuccessful in selling to third parties through its auction process. The properties identified will be placed in the Make Monroe Home Program. Pursuant to the agreement, Greater Rochester Housing Partnership, Inc. will fund Monroe 1 BOCES, Monroe 2 Orleans BOCES, and a contractor selected to place a pre-fabricated house on each vacant property for development in the Make Monroe Home Program.

Once developed with the pre-fabricated home, each property will be sold to an eligible, qualified home buyer who has completed home buyer classes conducted by approved local homebuyer education services. The sale proceeds will be reinvested back into the Make Monroe Home Program, in accordance with the funding restriction governing such money, to be used to develop, rehabilitate, renovate and market additional unsaleable distressed, vacant, or abandoned single family dwellings owned by Monroe County. Each property sold through the Make Monroe Home Program will be placed back on the real property tax rolls.

Approval from Your Honorable Body will be obtained for each individual property prior to it being transferred to a homebuyer pursuant to the Make Monroe Home Program.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Greater Rochester Housing Partnership, Inc., Monroe 1 BOCES, Monroe 2 Orleans BOCES, and a contractor selected by BOCES and Greater Rochester Housing Partnership, Inc. for the acceptance of pre-fabricated house(s) to be relocated to real property owned by Monroe County for hands-on-construction trades training pursuant to the Make Monroe Home Program.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

No net County support is required in the current Monroe County budget.

Greater Rochester Housing Partnership, Inc. is a not-for-profit corporation and the records in the Office of the Monroe County Treasury have indicated that it does not owe any delinquent Monroe County property taxes.

The records in the office of the Monroe County Treasury will be checked once the selected contractor and its principal officer(s) has been determined to ensure its principal officer(s) do not owe any delinquent Monroe County property taxes prior to work beginning.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley and Sheriff Todd K. Baxter.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$1,113,609, for the District Attorney's Office, the Office of the Sheriff, and the Department of Public Safety, Office of Probation and Community Corrections, for the Gun Involved Violence Elimination (GIVE) Partnership, for the period of July 1, 2019 through June 30, 2020.

This project provides resources enabling the Monroe County law enforcement community to target violent criminals, and those possessing weapons, in a coordinated effort to reduce violent crime in Monroe County. The ultimate goal of this partnership is to support targeted firearm and violent crime reduction efforts within Monroe County. This is the sixth year the County has received this grant. This year's funding represents a decrease of \$100,000 from last year.

Funds will be used specifically to help support the following programs in the following departments:

•District Attorney's Office: Partially support nine (9) existing Assistant District Attorney positions assigned to prosecute violent felons and criminals possessing illegal weapons, and to provide the Boys and Girls Clubs of Rochester, Inc. with a \$8,000 sub grant to continue its Project Step-Up Program;

- •<u>Sheriff's Office</u>: Support an existing Sheriff's Criminal Investigator (50%) and a Jail Deputy (100%), and underwrite part of the overtime costs of the Office of the Sheriff's participation in joint anti-crime efforts with the other GIVE agency partners;
- •Office of Probation and Community Corrections: Support the cost of an existing Senior Probation Officer (100%), a Probation Officer for the Swift, Certain & Fair Program (100%), a Probation Officer for the Swift, Certain & Fair Program (50%), enhanced electronic monitoring (GPS) capability, and underwrite the overtime costs of the Office of Probation and Community Correction's participation in joint anti-crime efforts with the other GIVE agency partners.

We have been notified of the funding amounts for the District Attorney's Office, \$570,997, the Office of the Sheriff, \$257,000, and the Department of Public Safety, Office of Probation and Community Corrections, \$285,612.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$1,113,609 grant from, and to execute contracts and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Gun Involved Violence Elimination Partnership, for the District Attorney's Office, the Office of the Sheriff, and the Department of Public Safety, Office of Probation and Community Corrections, for the period of July 1, 2019 through June 30, 2020.
- 2. Amend the 2019 operating budget of the District Attorney's Office by appropriating the sum of \$261,497 into general fund 9300, funds center 2508010000, Major Felony Bureau.
- 3. Amend the 2019 operating budget of the Office of the Sheriff by appropriating the sum of \$115,500 into general fund 9300, funds center 3803010000, Police Bureau Administration.
- 4. Amend the 2019 operating budget of the Department of Public Safety, Office of Probation and Community Corrections by appropriating the sum of \$136,893 into general fund 9300, funds center 2403050000, Special Services Intensive Supervision.
- 5. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

6. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Partial funding for this grant is included in the 2019 operating budget of the District Attorney's Office, general fund 9300, funds center 2508010000, Major Felony Bureau, Office of the Sheriff, general fund 9300, funds center 3803010000, Police Bureau Administration, and the Department of Public Safety, Office of Probation and Community Corrections, general fund 9300, funds center 2403050000, Special Services Intensive Supervision. The appropriated amount will adjust the current funding to that established by the grant.

This grant is 100% funded by the New York State Division of Criminal Justice Services. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body accept the Statewide Expansion of Hurrell-Harring Project grant from the New York State Office of Indigent Legal Services, in the amount of \$38,233,513, for the Office of the Monroe County Public Defender and the Office of the Monroe County Conflict Defender, for the provision of indigent legal services, for the period of April 1, 2018 through March 31, 2023, and authorize a contract with Pre-Trial Services Corporation of the Monroe County Bar Association for the Next Court Date Reminder Program and the Failure to Appear Program, in an amount not to exceed \$83,550, for the period of September 1, 2019 through August 31, 2020, with the option to renew for two (2) additional one-year terms in an amount not to exceed \$83,550 annually.

The Office of the Public Defender will use the funding for all of the salary costs equivalent to two (2) existing full-time Assistant Public Defender positions; to create a Next Court Date Reminder Program and a Failure to Appear Program; expert and investigative services; staff training; additional resources for the Counsel at First Appearance Program; modifications to the Office's case management program; and expand the funding for the Appellate Backlog Reduction Program. The Office of the Conflict Defender will use the funding for part or all of the salary costs equivalent to two (2) full-time clerical positions; expert and investigative services; staff training; establishing a training and mentorship program for the Assigned Counsel Program; funding for the Felony Conflict Plan; and creating a second chair program for homicide cases. We have been notified of the funding amounts for year one of the grant for the Office of the Monroe County Public Defender, (\$589,074), and the Office of the Monroe County Conflict Defender, (\$1,959,827). This is the first year the County has received this grant.

It has been determined that Pre-Trial Services Corporation of the Monroe County Bar Association is a sole source provider.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept the Statewide Expansion of Hurrell-Harring Project grant, in the amount of \$38,233,513 from, and to execute a contract and any amendments thereto with, the New York State Office of Indigent Legal Services, for the Office of the Monroe County Public Defender and the Office of the Monroe County Conflict Defender, for the provision of indigent legal services, for the period of April 1, 2018 through March 31, 2023.

- Amend the 2019 operating budget of the Office of the Public Defender by appropriating the sum of \$589,074 into general fund 9300, funds center 2601010000, Public Defender Administration.
- 3. Amend the 2019 operating budget of the Department of Public Safety by appropriating the sum of \$1,959,827 into general fund 9300, funds center 2402010000, Legal Representation.
- 4. Authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the Pre-Trial Services Corporation of the Monroe County Bar Association, 80 West Main Street, Rochester, New York 14614, for the Next Court Date Reminder Program and the Failure to Appear Program, in an amount not to exceed \$83,550, for the period of September 1, 2019 through August 31, 2020, with the option to renew for two (2) additional one-year terms in an amount not to exceed \$83,550 annually.

Subject: Amend the 2019-2024 Capital Improvement Program and the 2019 Capital Budget to Add a Project Entitled "Public Safety Training Center Storage Facility" and Authorize Financing for the Project

Honorable Legislators:

I recommend that Your Honorable Body amend the 2019-2024 Capital Improvement Program and the 2019 Capital Budget to add a project entitled "Public Safety Training Center Storage Facility" in the amount of \$550,000 and authorize financing for the project in the amount of \$550,000.

Monroe County owns the building located at 1190 Scottsville Road that is operated by Monroe Community College to provide public safety training to first responders. The Public Safety Training Facility was constructed and operated as a joint partnership among Monroe County, the City of Rochester and Monroe Community College. Providing specialized training requires the use and maintenance of specialized equipment. Currently, there is a need for indoor storage for fire trucks to avoid exposure to the elements to prevent costly repairs. Various sites and locations were analyzed to provide the most efficient use and least environmental disruption.

On June 25, 2019, the Public Safety Training Facility Operating Practices Council voted to construct this storage building and to reimburse Monroe County from the PSTF's reserve account. Such funding and any future funding will be paid to the County on a reimbursement basis and be used to redeem any short-term indebtedness incurred for the project.

This project was approved by the Monroe County Planning Board at its meeting on July 2, 2019.

The specific legislative actions required are:

- 1. Amend the 2019-2024 Capital Improvement Program to add a project entitled "Public Safety Training Center Storage Facility" in the amount of \$550,000.
- 2. Amend the 2019 Capital Budget to add a project entitled "Public Safety Training Center Storage Facility," in the amount of \$550,000.
- Authorize financing for the project entitled "Public Safety Training Center Storage Facility," in the amount of \$550,000.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this project, consistent with authorized, uses, will be included in the capital fund to be created and any other capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body authorize an intermunicipal agreement with the City of Rochester, in the amount of \$20,000, as reimbursement to the Rochester Police Department for participation in the County's FY2016 Complex Coordinated Terrorist Attack Grant (CCTA) Program, for the period of January 1, 2019 through July 31, 2020.

This grant provides funding to enhance preparedness and build capacity to prepare for, prevent, and respond to complex coordinated terrorist attacks. Monroe County works collaboratively with the City of Rochester in response and recovery of such events. Funds will be used to cover some backfill and overtime costs in the City of Rochester, resulting from CCTA exercise development and participation.

Funding for this grant was accepted by Your Honorable Body through Resolution 169 of 2018.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the City of Rochester, in the amount of \$20,000, as reimbursement to the Rochester Police Department for participation in the County's FY2016 Complex Coordinated Terrorist Attack Grant Program, for the period of January 1, 2019 through July 31, 2020.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this agreement is included in the 2019 operating budget of the Department of Public Safety, general fund 9300, funds center 2408030100, Office of Emergency Management. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Todd K. Baxter.

I recommend that Your Honorable Body authorize an intermunicipal agreement with the Fairport Central School District for the purchase of fuel for Monroe County Sheriff's Office vehicles, for the period of September 1, 2019 through August 31, 2020, with the option to renew for three (3) additional one-year periods, at the rate of ten cents (\$.10) per gallon above the New York State contract price, in an amount not to exceed \$150,000.

The Sheriff's Office has purchased gasoline from the other school districts in the past in an effort to reduce the time spent driving vehicles to fueling sites, thus increasing patrol coverage. This would be the 23rd year of this effort. This agreement would be consistent with other fueling agreements at the Sheriff's Office.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the Fairport Central School District, for the purchase of fuel for vehicles of the Monroe County Sheriff's Office, for the period of September 1, 2019 through August 31, 2020, with the option to renew for three (3) additional one-year periods, at the rate of ten cents (\$.10) per gallon above the New York State contract price, in an amount not to exceed \$150,000.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract is included in the 2019 operating budget of the Sheriff's Office, general fund 9001, funds center 3803020000, Road Patrol Zone A, and will be requested in future years' budgets. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Blue Heron Construction Company, LLC, in the amount of \$860,633, for general construction services, for the Rochester Pure Waters District's (District) Frank E. Van Lare Water Resource Recovery Facility (WRRF) Aeration System Improvements, Phase A – Test Aeration Basins Project.

The District owns, operates and maintains the WRRF located at 1574 Lake Shore Boulevard in the City of Rochester. The WRRF is an activated sludge sewage treatment facility originally constructed in the early 1900's. The structures serving as the 20 aeration basins are original to the WRRF and were converted to complete mix aeration basins with surface mechanical aerators around 1970. This complete-mix system with mechanical aerators was converted to a fine-bubble diffused air system between 2011 and 2015. These improvements converted the first quarter of each of the 20 aeration basins to unaerated selector zones. Phase A improvements will include the installation of flexible membrane diffusers in the unaerated selector zones of two test aeration basins and associated modifications of the air piping, influent lines, valves and slide gates. The results of Phase A will be used as the basis of design for the improvements to the remaining 18 aeration basins in a future Phase B.

The WRRF is an activated sludge sewage treatment facility originally constructed in the early 1900's. The structures serving as the 20 aeration basins are original to the WRRF and were converted to complete mix aeration basins with surface mechanical aerators around 1970. This complete-mix system with mechanical aerators was converted to a fine-bubble diffused air system between 2011 and 2015. These improvements converted the first quarter of each of the 20 aeration basins to unaerated selector zones. Phase A improvements will include the installation of flexible membrane diffusers in the unaerated selector zones of two test aeration basins and associated modifications of the air piping, influent lines, valves and slide gates. Also included within the project will be a digital hardware server and system software, digital communications interfaces and related equipment for connection to the existing parking network, and all cabling, raceways, power supplies and incidentals for a functional system. Training for airport and parking management staff as well as the removal of existing signs and graphics that are in conflict or redundant with the proposed guidance system will be part of the project.

This project will be partially funded by a New York State Department of Transportation grant (State Project PIN 4A08.98) up to a maximum of \$499,000 with the balance of the project's costs to be funded through a local share.



BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

WHEREAS, a project for the Lake Road West Fork Bridge Rehabilitation over Sandy Creek, P.I.N. 4BNY.26 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 95% Federal funds and 5% non-federal funds; and

WHEREAS, the County of Monroe will design, let and construct the Project; and

WHEREAS, the County of Monroe desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of the Project.

The purpose of this grant is to assist local health departments to develop emergency-ready public health departments in accordance with the National Preparedness Goals and the Centers for Disease Control and Prevention Preparedness Goals. Program objectives are: enhanced public health emergency preparedness including training, planning, equipment acquisition and response readiness; enhanced point of dispensing clinic readiness to include bioterrorism response (e.g. anthrax); expansion of a volunteer medical reserve corps; enhanced communicable disease planning (e.g. pandemic influenza); and enhanced disease surveillance. This will be the eighteenth year the County has received this grant. This year's funding represents a decrease of \$14,733 from the base amount from last year. However, an additional \$200,000 in restricted New York State Department of Health emergency placeholder funding is included. This funding could be made available in the event an actual public health emergency occurs during the grant period.

This contract will support the County's Medical Countermeasure Program. - Amend the 2019 operating budget of the Department of Public Health by appropriating the sum of \$295,860 into general fund 9300, funds center 5801090000, Public Health Preparedness.

- 3. Authorize the County Executive, or her designee, to execute a contract and any amendments thereto, with the University of Rochester, 601 Elmwood Avenue, Rochester, New York 14642, for the continuing development and sustainment of the County's Medical Countermeasure Program, in an amount not to exceed \$21,325, for the period of April 1, 2020 through June 30, 2020.
- 4. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
- 5. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Honorable Legislators:

I recommend that Your Honorable Body accept a five-year grant from the New York State Department of Health, in the amount of \$977,970, for the Tuberculosis Prevention and Control Program (formerly known as the Public Health Campaign – County Tuberculosis Program), for the period of April 1, 2019 through March 31, 2024.

The purpose of this grant is to provide enhanced tuberculosis prevention, control and elimination services to Monroe County residents. Funds will be used to cover partial salaries and benefits for staff nurses who perform case management, screening, diagnosis, and treatment of infected and at-risk clients. Additionally, staff outreach workers will provide directly observed therapy and assist with screening and contact investigations. This will be the twenty-seventh year the County has received this grant. This year's funding level is the same amount as the previous 12-month period.

The specific legislative actions required are:
