Honorable Legislators:

Monroe County has long been a leader in innovative sustainability policy that has been both environmentally friendly and cost effective. The County has demonstrated its leadership through its eight (8) LEED Certified facilities, 400+ vehicle green fleet, Waste to Watts Program, solar initiatives, and EcoPark.

Protecting our environment is key to maintaining our quality of life and preserving our natural resources for future generations. Although there are many ideas on how to best protect our environment, it must start with individual accountability. This Honorable Body can continue to be a leader in environmental policy by setting goals and objectives that will improve sustainability, reduce emissions and strengthen resiliency.

Many communities across the country have looked towards Climate Actions Plans to coordinate and centralize environmental policy and initiatives. In order to generate such a plan for Monroe County, we must first assemble a group of stakeholders, subject-matter experts, and policy-makers to provide direction and formulate action items.

Therefore, we propose that This Honorable Body create a Climate Action Plan Advisory Committee for the express purpose of creating a Climate Action Plan for Monroe County.

The specific legislative actions required are:

- 1. Create a Climate Action Committee with the following duties:
 - a. To create a Climate Action Plan for Monroe County.

- 2. The Committee shall be comprised of eleven (11) members:
 - a. Seven voting members who shall be confirmed by the Legislature: one (1) member shall be a Legislator recommended by the President of the Legislature; one (1) member shall be a Legislator recommended by the Majority Leader; one (1) member shall be a Citizen recommended by the President of the Legislature; one (1) member shall be a Citizen recommended by the Majority Leader; one (1) member shall be a Citizen recommended by the Majority Leader; one (1) member shall be a Citizen recommended by the Minority Leader; one (1) member shall be a Citizen recommended by the County Executive.
 - b. Four non-voting members who shall be appointed as follows: one (1) member shall be a Student Advisor appointed by the Majority Leader; one (1) member shall be a Student Advisor appointed by the Minority Leader; one (1) member shall be a Student Advisor appointed by the County Executive; one (1) exofficio member shall be the Director of Environmental Services or their designee.
- 3. Adopt the resolution as attached.

This proposed resolution shall have no impact on the revenues or expenditures of the current Monroe County Budget.

AUTHORIZING CREATION OF CLIMATE ACTION PLAN ADVISORY COMMITTEE

BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

- Section 1. Pursuant to Sections C2-4 (B)(5) and C3-2 (A)(10) of the Monroe County Charter, the County Executive and Legislature hereby create a Climate Action Plan Advisory Committee (the "Committee") for the purpose of creating a Climate Action Plan.
- Section 2. The Committee shall be composed of seven (7) voting members who are Monroe County residents and who shall be appointed by the President of the Legislature and confirmed by the Legislature in the following manner:
 - 1. One (1) member shall be a Legislator recommended by the President of the Legislature;
 - 2. One (1) member shall be a Legislator recommended by the Majority Leader;
 - 3. One (1) member shall be a Legislator recommended by the Minority Leader;
 - 4. One (1) member shall be a Citizen recommended by the President of the Legislature;
 - 5. One (1) member shall be a Citizen recommended by the Majority Leader;
 - 6. One (1) member shall be a Citizen recommended by the Minority Leader;
 - 7. One (1) member shall be a Citizen recommended by the County Executive.
- Section 3. The Committee shall also include four (4) members without voting rights who are Monroe County residents and who shall be appointed by letter from the appointing authority to the President of the Legislature in the following manner without confirmation by the Legislature:
 - 1. One (1) member shall be a Student Advisor appointed by the Majority Leader;
 - 2. One (1) member shall be a Student Advisor appointed by the Minority Leader;
 - 3. One (1) member shall be a Student Advisor appointed by the County Executive;
 - 4. One (1) ex-officio member shall be the Director of Environmental Services or his designee.
- Section 4. All appointments shall be made within thirty (30) days of the effective date of this resolution.
- Section 5. Student Advisors shall be children under the age of eighteen (18) or adults under the age of twenty-four (24) who attend an educational program at least five months per calendar year.
- Section 6. Student Advisors shall serve at the pleasure of their appointing authority and may be replaced by their appointing authority with a new appointment made in the manner described in Section 3.
- Section 7. Officers: Officers of the Climate Action Plan Advisory Committee shall be a Chair, Vice Chair and Secretary, each of whom shall be elected by the Committee.

Section 8. Officer Duties

- 1. The Chair shall have general supervision of the work of the Committee and shall preside at all meetings.
- 2. The Vice Chair shall perform the duties of the Chair during the absence of the Chair.

3. The Secretary, who is not required to be a member of the Committee, shall notify the members of the time and place of all meetings of the Committee, shall ensure the accuracy of minutes of the meetings and shall perform such other secretarial duties as may be designated by the Committee.
Section 9. In accordance with the purpose set forth in Section 1, the Committee shall identify and review practices and policies that may impact environmental sustainability and identify any practices and policies which may reduce residential and commercial environmental impact.
Section 10. Any practices or policies included or recommended as part of the Climate Action Plan shall also include an estimated cost and timeline for implementation.
Section 11. The Committee may request relevant information from all County Agencies and have access to County employees.
Section 12. The Committee shall issue its Climate Action Plan to the Monroe County Legislature and Monroe County Executive within twelve (12) months of its appointment.
Section 13. The Committee shall terminate upon the issuance of its Climate Action Plan.
Section 14. This resolution shall take effect in accordance with Section C2-7 of the Monroe County Charter.

RE: Requesting a Report from Monroe County Administration for Deployment of Bleed **Control Kits in County Owned and Operated Facilities**

Honorable Legislators:

Monroe County has long been a leader in the area of emergency preparedness. Yet, the County must remain at the forefront on the issue to better protect the community. While innovation and technology is driving much of the changes in emergency preparedness, sometimes simplicity and intuitiveness are needed most.

Sadly, public buildings are often targets for those seeking to inflict violence or commit acts of terrorism. While law enforcement does an exceptional preventing these acts, Monroe County must always be prepared to face new and evolving threats. Bleed Control Kits are an excellent example of a simplistic and intuitive product that could save lives in the event of an emergency. These kits are designed to provide users with immediate access to products intended to stop traumatic hemorrhaging. They often include tourniquets, trauma shears, gauze dressings, bandages, and latex gloves. All bleed kits include detailed, easy-to-follow instructions for untrained users.

Bleeding poses one of the greatest risks during acts of mass violence or terrorism. Studies show uncontrolled bleeding can be fatal if untreated within five to ten minutes of the initial trauma. In many instances, fellow citizens or employees are the first line of treatment for traumatic injuries. But without the tools necessary, they are ill-equipped and ill-prepared to administer potentially lifesaving care.

Monroe County operates in many different types of facilities – each of posing different risks and challenges. Traditionally, the number of Bleed Control Kits needed for each facility is determined based on size of building, accessibility to the public, and frequency of visitors. With so many variables in existence, this Honorable Body must first have accurate and detailed information to better make policy advisements of the deployment of Bleed Control kits in Monroe County owned and operated facilitates.

Therefore, I propose that this Honorable Body request a report from the Administration containing recommendations for the deployment of Bleed Control Kits in County owned and operated facilities. In requesting this report, this Honorable Body asks that the "3 Minute Rule" be followed – meaning a Bleed Control Kit should be accessible to all users in a distance that would take three minutes or less to retrieve by foot. Additionally, this report should include estimated costs, potential revenue sources, timeline for deployment, and proposed revisions to any applicable Incident Response Plans.

The specific legislative action required is:

- 1. Request a report from the Administration on the deployment of Bleed Control kits in County owned and operated facilities:
 - a. The report shall adhere to the "3-Minute Rule".
 - b. The report shall include estimated costs, potential revenue sources, timeline for deployment.
 - c. The report shall include proposed revisions to any applicable Incident Response Plans.
 - d. The report shall be issued to the Legislature within six (6) month of the effective date of the corresponding resolution.

This proposal will have no associated cost and no impact upon the expenditures and revenues of the Monroe County Budget.

Re: Memorializing Governor Andrew M. Cuomo and the New York State Legislature to Raise Reimbursement Rates for the State-Controlled Portions of the Preschool Special Education Program

Honorable Legislators:

Preschool Special Education is a state-mandated service that is implemented locally by our Special Children's Services. Last year, Monroe County increased all County-set reimbursement rates for vital local Preschool Special Education services and continues to seek out ways to strengthen the Preschool Special Education program. The 15% rate increase for these services represented the first adjustment to the local Preschool Special Education rate structure in a decade.

While many components of Preschool Special Education services are controlled by Counties, New York State is still responsible for some of these rates. Stagnant reimbursement rates at the State level have resulted in a shortage of direct service providers statewide who have been forced to provide services at a loss or discontinue their program.

While we have seen New York State pass a budget that includes a minor increase of 5% for Early Intervention reimbursements rates, we have yet to see this increase enacted and there has been no movement in making increases to the state controlled portions of Preschool Special Education. New York State must do everything in their power to guarantee the fiscal solvency of these programs for providers and the children and families that rely on them.

Therefore, we urge you to join us in calling upon the New York State Legislature and Governor Cuomo to match Monroe County's 15% rate increase to local Preschool Special Education rates by increasing the State-set reimbursement rates for Preschool Special Education by an equivalent 15%. We must take these important steps to ensure that children and families receive the necessary services owed to them.



Re: Memorializing President Donald J. Trump to Immediately Renegotiate Plan 2014 and the New York State Assembly and Senate to Pass and Governor Andrew M. Cuomo to Sign Bill A08384

Honorable Legislators:

Lake Ontario and the Great Lakes are a staple for Monroe County residents, property owners and business owners. Approximately 37 miles of the Lake Ontario Shoreline are in the County of Monroe. Over the past four years, the southern shoreline of Lake Ontario has seen an increasing level of water, exceeding record peaks. Several years ago the International Joint Commission announced its intention to seek a water level regulation plan and formed Bv7, which failed to address the concerns of the community, forcing them to create a new proposal with nearly the same recommendations, Plan 2014.

Plan 2014 has failed Monroe County. As required in the 2016 Supplementary Order from the International Joint Commission, agreed to by the United States and Canada in December of 2016, Plan 2014 failed to improve environmental performance while maintaining most of the benefits provided to other interests. Based on historical observations and projected future conditions, at a minimum, Lake Ontario water levels are expected to range from a high of 75.88m (248.9 ft.) to a low of 73.56m (241.3 ft.) at infrequent intervals. Last year, Lake Ontario reached 79.50m (249.02 ft.), exceeding the record peak of 75.88m (248.95 ft.) set in 2017, and will continue to rise gradually unless Plan 2014 is renegotiated. This year, Lake Ontario has risen up to 9 inches higher than this time last year, indicating we are on track for greater flooding than previously seen in 2019. Additional rises will be primarily driven by how much precipitation falls across the basin. If efforts are not made to renegotiate Plan 2014, we will continue to see these irregular water levels.

The implementation of Plan 2014 continues to threaten severe damage to lakeshore properties in Monroe County including key County infrastructure. The New York State Assembly and Senate must pass and Governor Cuomo must sign Bill A08384 to help negate the burden and damage caused to Lake Ontario shoreline residents due to Plan 2014.

The fact remains that the high water levels must be addressed and reduced in order to prevent future flooding and further damages from occurring. The implementation of Plan 2014 has failed the many counties on the southern shoreline, especially Monroe County. Based on the 2017 high water events, NYS tax payer dollars were spent in the amount of \$95 million, plus FEMA funds, and it is expected that will happen again.

Together, we can work to find a better solution to the rising shore levels and preserve Monroe County's beautiful stretch of 37 miles on Lake Ontario shoreline while also protecting unduly burdened lakeshore residents.



Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Make Investments in Veteran Services

Honorable Legislators:

Monroe County is home to over 30,000 veterans. These brave men and women sacrificed immensely for the betterment of our Country and oftentimes continue their service to country and community when they return home. Monroe County is fortunate to have first-class service programs to support veterans; yet we can and must do more.

Due in part to the looming \$6-billion State budget deficit, the New York State Division of Veteran Affairs has underfunded some of its local government support. This has caused counties across the State to develop unique incentives to continue to recruit and retain its veteran populations. It is critical that veterans receive the first-rate care they deserve.

The New York State Legislature and Governor Andrew M. Cuomo must increase funding and support of local veteran services. Additional funding must be made available for local veterans' affairs agencies so that counties can provide additional resources and services to our veterans. To better provide these local veteran services, the New York State Division of Veteran Affairs should be required to share DD-214 forms with county veteran service agencies and the definition of veteran must be expanded to recognize the service who veterans who have completed 20 years of service. Counties who create veteran trust funds should be provided a one-time seed fund equal to \$1 per veteran as of the last U.S. Census to assist the continued operational success of the Trust Fund.

Outside of additional funding, changes should be made to further improve the quality of life for our veterans. In taxation, local governments should be authorized to allow veterans to receive exemptions from paying hotel/motel occupancy taxes, be afforded the flexibility to enact a local sales tax exemption on vehicles for veterans who are partially disabled and allowed to provide local sales tax exemptions for vehicle purchases and adaptations. Programs should be expanded to provide veterans with additional discounts on hunting and fishing licenses and state

park entrance fees. To provide employment and opportunity, all public institutions of higher education should be mandated to participate in the American Council on Education to provide college credit for military experience and a veterans' green energy jobs program should be created to train and link veterans with sustainable, environmentally friendly jobs for the changing economy. Additionally, veteran court availability must be expanded throughout New York State.

These are few of the many ways our state can better improve the services provided to and the lives of our great veteran citizens. The men and woman who have sacrificed so much for our Country should be afforded first-rate support, care and encouragement. Therefore, we urge you to join us in calling upon the New York State Legislature and Governor Andrew M. Cuomo to make these and further investments in Veteran Services.



Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Address the Volunteer Firefighter and EMS Recruitment and Retention Crisis

Honorable Legislators:

Throughout the State of New York, counties are struggling with a shortage of volunteer firefighter and EMS personnel in their communities. The shortage of the available personnel is both an issue within volunteer fire companies, as well as community ambulance corps. Volunteer firefighters are a fiscally responsible solution to helping better protect our communities. According to a study conducted in 2015 by the Fireman's Association of the State of New York, volunteer firefighters alone save New York State more than \$3 billion each year.

Since the 1990s the number of volunteer firefighters in New York has decreased. The Fireman's Association of the State of New York has recorded that the number of volunteer firefighters has dropped from 110,000 in 1990 to fewer than 100,000 today. One of the variables responsible for the decrease in the volunteer firefighters and ambulance corps is that they do not receive any direct monetary compensation for their service. Counties across the state have been working on this issue for decades.

In 2008, Westchester County passed a local law to provide a real property tax exemption to volunteer firefighters and volunteer ambulance service members and to continue this exemption in the case of certain un-remarried spouses of deceased volunteers. Following in their suit, Nassau County also provided a property tax exemption for volunteer firefighters and ambulance workers and offers a lifetime exemption to members with over 20 years of volunteer service. Suffolk County has also passed similar legislation in 2003 that provided an exemption from taxation to the extent of 10% of the assessed value of such property for county purposes and exclusive of special assessment for property owned by an enrolled member of an incorporated volunteer fire company, department or incorporated voluntary ambulance service or such enrolled member or spouse, or deceased enrolled member's un-remarried spouse.

Monroe County prides itself on being a champion for our first responders. New York State should follow in the lead of other counties in implementing federal laws that will give the many men and women who volunteer their days and nights some form of compensation. This will not only give back to those members but help rise the recruitment numbers and retention rate for Volunteer Firefighters and EMS responders.

Honorable Legislators,

Early intervention has successfully helped children with disabilities and their families. We have witnessed first-hand the children who have benefitted and it is imperative we have enough providers and service coordinators to carry out this important work at a fair wage. In addition, we appeal to Governor Cuomo to ensure the Early Intervention Program more closely aligns with the Individuals with Disabilities Education Act (IDEA), a federal education law, of which it is part.

Reimbursement rates for providers and service coordinators for EI and Preschool Special Education have not been adjusted since 2011, and as a result many providers are dropping out of the program. Counties across New York State, including Monroe County, are facing a shortage of providers, as well as service coordinators. This is quickly becoming a crisis, especially in Monroe County. In addition, we ask New York State to revise the wage structure statewide to ensure rates are in keeping with the cost of living and to establish rate equity between the EI and Preschool Special Education programs.

Specifically, we ask that the State:

- Raise reimbursement rates for EI and Preschool Special Education Services by a minimum of fifteen percent each.
- Change state health law relating to coverage for EI services by passing bills A00356/S03338, and signing into law to increase reimbursement from private health insurance companies.
- O Authorize a covered lives assessment for EI Insurance that requires insurance companies to pay into a "pool" from which providers can invoice directly.
- Establish funding and reimbursement rate equity between the EI Preschool Special Education systems.

Therefore, we respectfully urge you to join us in memorializing the NYS Assembly and Senate to Pass, and Governor Andrew Cuomo to Sign A00356 and S03338 Entitled, "Provides for State Funding to Municipalities for Early Intervention Services for Toddlers with Disabilities and their Families".

Honorable Legislators:

I recommend that Your Honorable Body enact a Local Law authorizing the lease with the Gallina Development Corp. to a total term of twenty (20) years for office space and operation of the Monroe County Sheriff Zone B Substation. The substation will be located at Calkins Road, Town of Henrietta, New York and will consist of approximately 16,260 square feet located on a 5.189 acre parcel. Monroe County will pay rent of \$18.33 per square foot for years one (1) through five (5), \$18.83 per square foot for years six (6) through ten (10), and \$19.83 per square foot for years eleven (11) through fifteen (15), and \$20.83 per square foot for years sixteen (16) through twenty (20), plus common area charges each year. The lease may be renewed for one (1) additional five (5) year term upon mutual consent of the parties.

County Law Section 215 requires adoption of a local law for any lease in excess of five (5) years.

A lease of space at Calkins Road, would enable the Sheriff's Department to be centrally located in the zone providing improved response time to calls for service. The current facility is outdated for operations and requires significant improvement. The new site will be an emergency operations site in the event of a significant event or natural disaster.

- 1. Schedule and hold a Public hearing on the proposed Local Law.
- 2. Enact a Local Law authorizing the County Executive, or his designee, to enter into a lease with Gallina Development Corp., with offices located at 1890 South Winton Road, Suite 100, Rochester, New York, for a total term of twenty (20) years, for the purpose of providing approximately 16,260 square feet of office space at Calkins Road, Town of Henrietta, at a cost of \$18.33 per square foot for years one (1) through five (5), \$18.83 per square foot for years six (6) through ten (10), and \$19.83 per square foot for years eleven (11) through fifteen (15), and \$20.83 per square foot for years sixteen through twenty (20), plus common area charges each year. The lease may be renewed for one (1) additional five (5) year term upon mutual consent of the parties.

This matter is being referred to Your Honorable Body at the request of Sheriff Todd K. Baxter.

2. Amend the 2020 operating budget of the Office of the Sheriff by appropriating the sum of \$32,000 into general fund 9300, funds center 3803010000, Police Bureau Administration.

This grant is 100% funded by the Federal Department of Homeland Security Federal Emergency Management Agency (administered by the New York State Division of Homeland Security and Emergency Services). No net County support is required in the current Monroe County budget.

The 300 Ramp has been the traditional location for aircraft tie-downs, bulk hangar aircraft storage, and flight school operations. The 300 Ramp is located on the south side of the airfield and can be also accessed from Scottsville Road. The 300 Ramp is one of the oldest apron areas on the airport and the pavement is found to be in fair condition. A rehabilitative treatment of milling and resurfacing would restore the pavement to good condition. Areas of the ramp are distressed and if left unrepaired, the pavement will start separating, creating a Foreign Object Debris (FOD) hazard. The ramp area is approximately 201,700 square feet.

The Tie-down area is approximately 57,000 square feet of asphalt pavement. The pavement is in very poor condition and full-depth reconstruction is recommended. New tie-down anchors would be included with the asphalt pavement reconstruction.

Designating <u>The Daily Record</u> and the <u>Rochester Business Journal</u> will allow the County to maintain a broad circulation while efficiently utilizing financial resources. These newspapers have been designated the official newspapers since 1997.

The specific legislative actions required are:

- 1. Designation of <u>The Daily Record</u> and the <u>Rochester Business Journal</u> as the official newspapers for the year 2020 for publication of all local laws, notices and other matters required by law to be published.
- Said official newspapers shall be required to send copies of all pertinent information required by state law to be published in the official newspapers to the clerks of each respective town, village and city in Monroe County. In addition, each library system and fire district within the County should also be provided with copies of said local laws, notices and other matters required by state law to be published in official newspapers. Furthermore, such pertinent information should be posted in a conspicuous manner for public review.

The legislative action requested in this referral is not an "Action," as that term is defined in 6 NYCRR § 617.2(b), and is not subject to review under the State Environmental Quality Review Act.
