I recommend that Your Honorable Body confirm the appointment of Hon. Brian E. Marianetti and the reappointment of Mr. William Gibson to the New York State Department of Environmental Conservation Region 8 Fish and Wildlife Management Board, pursuant to Section 11-0501 of the New York State Environmental Conservation Law.

Hon. Brian E. Marianetti will serve as the Legislature Member. His appointment is effective immediately and will expire on December 31, 2015.

Mr. William Gibson will serve as the Sportsman Member. His reappointment is effective immediately and will expire on December 31, 2015.
