Re: Memorializing the New York State Assembly to Pass, and Governor Andrew M. Cuomo to Sign, Assembly Bill A2922 Requiring the State to Fund any Program which Imposes a Mandate upon Municipal Corporations or School Districts

Honorable Legislators:

As County Officials, we strive to provide county taxpayers with the various programs and services that they need at a cost that is efficient and sustainable. For the past 9 years, Monroe County has held the line on property taxes for its residents and has continued to be in compliance with the New York State Property Tax Cap. While we have made continuous and successful strides to keep our budget balanced and our property taxes stable, we still face strict budget restrictions due to the State imposing unfunded or underfunded mandates.

When Governor Andrew M. Cuomo first introduced the New York State Property Tax Cap in 2011, he promised to provide meaningful mandate relief to counties and local municipalities; six years later, we are still waiting for his words to become actions. Mandated programs alone account for 85% of the Monroe County 2017 Operating Budget. Unlike the funding for every other state in the country, New York resorts to accumulating state funds by means of local municipality property taxes. Because of this, New York residents and businesses have the highest property taxes in the nation.

Prolonged inaction at the state level has forced local leaders to make hard decisions including raising property taxes, cutting programs, and eliminating services. In addition, state imposed mandates have made it much more difficult to attract and keep businesses and jobs in our region and much of Upstate New York. The budget-making process for counties and their property taxpayers should not be bogged down nor influenced by Albany's desire to shift the blame for high property taxes onto county and local officials.

This legislation has already passed the State Senate, but remains stalled in the State

Assembly. It would amend the general municipal law and the education law to prohibit the implementation of certain programs mandated for municipal corporations and school districts unless they are fully funded by the state. This is a step in the right direction as we continue to push for total fiscal relief for local taxes that are committed to state mandated programs.

For the aforementioned reasons, we urge you to join us in calling on the State Assembly to pass, and the Governor to sign, Assembly Bill A2922 that would require the State to fund any program which imposes a mandate upon municipal corporations or school districts. It is time for our State Assembly to join the State Senate in passing this important legislation that would to bring accountability back to state government and provide real mandate relief for our local communities and taxpayers.

Re: Memorializing the New York State Legislature to Provide New York State Counties
Permanent Authority to Continue their Current Sales Tax Rates

Honorable Legislators:

Providing county taxpayers with necessary quality of life services and programs at a reasonable cost is critical. Monroe County has been able to keep property taxes stable and comply with New York State's Property Tax Cap for the past 9 years. Despite the strict limitations of unfunded and underfunded mandates by the State, Monroe County has continued to work in a manner that fits our taxpayer's needs.

This past June, the State Senate and State Assembly failed to pass home rule requests for local sales tax extenders for 57 out of 62 counties in New York before the legislative session ended. Though the sales tax extender legislation was passed in the Legislature's Extraordinary Meeting at the end of June, there was a significant delay. Without the timely passage of this legislation, county sales tax extenders would have expired at the end of this year leaving many counties with large budget gaps, including an \$83 million budget gap in Monroe County.

Granting counties in New York State permanent authority over sales tax rates will enable counties and local governments that receive a share of revenues to fund programs that are mandated by New York State, as well as local services that are critical in our community. Because of the State's delayed action on county home rule requests, it is clear that providing counties with permanent authority is necessary. This would be a beneficial reform to this process as it would provide greater efficiency and ensures that future county budgets would not be delayed by Albany politics.

Therefore, we urge you to join us in calling on our State Legislators to provide New York State Counties with permanent authority to continue their current sales tax rate. This is necessary to eliminate Albany politics from interfering with the budget process in New York State Counties.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body accept a grant from the Institute for Police, Mental Health & Community Collaboration, in the amount of \$15,000, for the development of a Crisis Intervention Team (CIT) in Monroe County, for the period of May 1, 2017 through December 31, 2017.

The New York State Senate awarded the funding to the New York State Office of Mental Health, who in turn contracted with the Institute for Police, Mental Health & Community Collaboration to provide technical assistance to develop a CIT. The CIT is a police-based crisis intervention team with community, health care and advocacy partners and offers a forum for effective problem solving in criminal justice and mental health care system interactions. The grant funds will be used to reimburse the Sheriff's Office for overtime and backfill costs incurred for CIT training. This is the first year the County has received this grant.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$15,000 grant from, and to execute a contract and any amendments thereto with, the Institute for Police, Mental Health & Community Collaboration, for the development of a Crisis Intervention Team in Monroe County, for the period of May 1, 2017 through December 31, 2017.

- 2. Amend the 2017 operating budget of the Office of the Sheriff by appropriating the sum of \$15,000 into general fund 9300, funds center 3803010000, Police Bureau Administration.
- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This grant is 100% funded by the New York State Office of Mental Health (administered by the Institute for Police, Mental Health & Community Collaboration). No net county support is required in the current Monroe County budget.

Acceptance of a Grant from the United States Department of Justice, United States Attorney, for the Organized Crime Drug Enforcement Task Forces State or Local Overtime and Authorized Expense/Strategic Initiative Program

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body accept a grant from the United States Department of Justice, United States Attorney, in the amount of \$5,000, for the Organized Crime Drug Enforcement Task Forces (OCDETF) State or Local Overtime and Authorized Expense/Strategic Initiative Program, for the period of May 23, 2017 through May 24, 2018.

The purpose of this program is to allow local agencies to assist in an overtime capacity when needed for OCDETF investigations of major drug trafficking organizations. The grant will pay a portion of the costs incurred by the Sheriff's Office for overtime. This is the fifth time the County has received this grant. This period's funding represents a decrease of \$10,000 from the last grant period.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$5,000 grant from, and to execute a contract and any amendments thereto with, the United States Department of Justice, United States Attorney, for the Organized Crime Drug Enforcement Task Forces State or Local Overtime and Authorized Expense/Strategic Initiative Program, for the period of May 23, 2017 through May 24, 2018.
- 2. Amend the 2017 operating budget of the Office of the Sheriff by appropriating the sum of \$5,000 into general fund 9300, funds center 3803010000, Police Bureau Administration.

- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This grant requires a \$2,000 local match for fringe benefits not reimbursed by the grant. This match is included in the 2017 operating budget of the Office of the Sheriff, general fund 9001, funds center 3803010000, Police Bureau Administration, and will be included in future years' budgets. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize an intermunicipal agreement with the Rush-Henrietta Central School District for the purchase of fuel for vehicles of the Monroe County Sheriff's Office, for the period of October 1, 2017 through September 30, 2018, with the option to renew for three (3) additional one-year periods, at the rate of the New York State contract price plus ten cents (\$.10) per gallon.

The Sheriff's Office has purchased gasoline from the Rush-Henrietta Central School District in the past in an effort to reduce the time spent driving vehicles to fueling sites, thus increasing patrol coverage. This agreement is consistent with other fueling arrangements negotiated by the Sheriff's Office. This will be the fifteenth year of this effort.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the Rush-Henrietta Central School District, for the purchase of fuel for vehicles of the Monroe County Sheriff's Office, for the period of October 1, 2017 through September 30, 2018, with the option to renew for three (3) additional one-year periods, at the rate of the New York State contract price plus ten cents (\$.10) per gallon.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this agreement is included in the 2017 operating budget of the Office of the Sheriff, general fund 9001, funds center 3803030000, Sheriff Road Patrol B Zone, and will be requested in future years' budgets. No additional net County support is required in the current Monroe County budget.

Auditing Services Relating to the Department of Transportation Consultant

Agreements

Honorable Legislators:

I recommend that Your Honorable Body authorize a term contract with EFPR Group, CPA's, PLLC, in an amount not to exceed \$40,000, for professional auditing services related to Department of Transportation consultant agreements, for the period of September 1, 2017 through August 31, 2020.

The Federal Highway Administration (FHWA) and the New York State Department of Transportation (NYSDOT) provides federal and state assistance to localities to reconstruct, rehabilitate, and maintain bridges, roads and related transportation infrastructure. The County contracts with consultants who are engaged to provide professional services related to preliminary engineering design, final design, and construction inspection and supervision. Major funding for the projects comes from one Federal Highway Administration program in which the State shares a portion of the non-federal cost (Marchiselli Aid), and from other related FHWA programs. NYSDOT and FHWA administrative procedures require the County to obtain close out audits for consultant agreements that exceed a certain dollar threshold (currently \$300,000). These audits are to be performed by an independent Certified Public Accounting firm in accordance with Governmental Accounting Standards. The audits will be performed on an asneeded basis as projects that meet the required dollar threshold are completed. The costs of these audits are fully reimbursed by New York State.

A request for proposals was issued for this service, with EFPR Group, CPA's, PLLC selected as most qualified to perform this service.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with EFPR Group, CPA's, PLLC, 280 Kenneth Drive, Suite 100, Rochester, NY 14623, for auditing services related to Department of Transportation consultant agreements, in an amount not to exceed \$40,000, for the period of September 1, 2017 through August 31, 2020.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract, consistent with authorized uses, is included in various capital funds, and any future capital funds, relating to the project to which the audited consultant agreement pertains. No net county support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither EFPR Group, CPA's, PLLC, nor any of its principal officers, owe any delinquent Monroe County property taxes. The principal partners of the firm are:

State Department of Health for the Drinking Water Enhancement Program

Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 215 of 2015 to accept additional funding from the New York State Department of Health, in an amount not to exceed \$28,373, for the Drinking Water Enhancement Program, for the period of April 1, 2015 through March 31, 2020.

By Resolution 215 of 2015, Your Honorable Body authorized the acceptance of a grant from the New York State Department of Health for the Drinking Water Enhancement Program. The purpose of this grant is to enhance local drinking water programs and to provide increased oversight of public and private water supplies in Monroe County, along with ensuring continued compliance with the Federal Safe Drinking Water Act and the New York State Sanitary Code. This additional funding will be used for existing salary, benefits and grant costs. The additional funding will bring the grant total to \$721,428.

The specific legislative actions required are:

- 1. Amend Resolution 215 of 2015 to accept an additional \$28,373 from, and to authorize the County Executive, or her designee, to execute a contract and any amendments thereto with, the New York State Department of Health, for the Drinking Water Enhancement Program, bringing the total program award to \$721,428, for the period of April 1, 2015 through March 31, 2020.
- 2. Amend the 2017 operating budget of the Department of Public Health by appropriating the sum of \$28,373 into general fund 9300, funds center 5806010000, Environmental Health Administration.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Partial funding for this grant is included in the 2017 operating budget of the Department of Public Health, general fund 9300, funds center 5806010000, Environmental Health Administration. The appropriated amount will adjust the current funding to that established by the grant.

This grant is 100% funded by the New York State Department of Health. No additional net County support is required in the current Monroe County budget.

Services for Residents of Monroe Community Hospital

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the Catholic Diocese of Rochester, in an amount not to exceed \$43,200, to provide Roman Catholic sacramental and religious services for residents of Monroe Community Hospital, for the period of October 1, 2017 through September 30, 2018, with the option to renew for two (2) additional one-year terms, in an amount not to exceed \$43,200 annually.

The New York State Department of Health requires health care facilities assure that residents/patients have the right to participate in religious activities and arrange for opportunities for religious worship and counseling for any resident requesting such services. The Catholic Diocese of Rochester will provide Monroe Community Hospital with a full time chaplain to provide sacraments and religious services. The Catholic Diocese is the sole vendor of Roman Catholic services in Monroe County.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract and any amendments thereto, with the Catholic Diocese of Rochester, 1150 Buffalo Road, Rochester, New York 14624, to provide Roman Catholic sacramental and religious services for residents of Monroe Community Hospital, in an amount not to exceed \$43,200, for the period of October 1, 2017 through September 30, 2018, with the option to renewal for two (2) additional one-year terms, in an amount not to exceed \$43,200 annually.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract is included in the 2017 operating budget of Monroe Community Hospital, hospital fund 9012, funds center 6201010000, Monroe Community Hospital, and will be requested in future years' budgets. No net County support is required in the current Monroe County budget.

The Catholic Diocese of Rochester is a not-for-profit agency, and the records in the Office of the Monroe County Treasury have indicated that it does not owe any delinquent Monroe County property taxes.

Acceptance of a Grant from the New York State Office for the Aging to Pilot the Aging

Mastery Program

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Office for the Aging (NYSOFA), in the amount of \$5,100, to pilot the Aging Mastery Program (AMP), for the period of November 1, 2016 through October 31, 2017.

This grant will be used to pilot the AMP, an evidence based program recognized by the US Administration on Aging, and developed by the National Council on Aging, to help older adults take key steps to improve their well-being, add stability to their lives, and strengthen their ties to communities. This program uses peer support and incentives to help older adults create actionable goals and sustainable behaviors in 10 core classes in an area where older adults congregate, such as a senior center. This grant will be used to pay for the required one-time licensing fees, program materials, and incentives for participants. Should the pilot program prove successful in our community, the Monroe County Office for the Aging will consider identifying funding and incorporating the AMP into the existing array of programs and services offered to improve the health and wellness of older adults in our community.

NYSOFA will monitor the effectiveness of this program, compare results of the eight (8) other participating counties, and report the results back to these counties. The other counties include: Franklin, Orange, Westchester, Broome, Tompkins, Steuben, Oneida, and Chautauqua. This is the first year Monroe County has received this grant.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$5,100 grant from, and to execute a contract and any amendments thereto with, the New York State Office for the Aging, to pilot the Aging Mastery Program, for the period of November 1, 2016 through October 31, 2017.
- 2. Amend the 2017 operating budget of the Department of Human Services, Office for the Aging, by appropriating the sum of \$5,100 into general fund 9001, funds center 5501050000, Education, Training and Wellness.

- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 4. Should funding for this program be terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This contract is 100% funded by the New York State Office for the Aging. No net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Roy Teitsworth, Inc. (Teitsworth), to provide auctioneer services, for the period of September 1, 2017 through August 31, 2018, with the option to renew for two (2) additional one-year periods, with Teitsworth receiving 9% of auction proceeds to be deducted from the net proceeds from the sale of County equipment, and the County receiving proceeds in the amount of 10% of the commissions earned by Teitsworth from the sale of other Municipalities' equipment, and the County receiving 5% of the commissions earned by Teitsworth from the sale of private sector sellers' equipment at auctions sponsored by Monroe County.

Teitsworth will provide auction services for the Department of Engineering Services, Division of Fleet Maintenance, the Sheriff's Office, and any other County departments that wish to sell excess or surplus equipment at auction. Teitsworth will be responsible for all aspects of the County auction at the Monroe County Fleet Center, held annually in the fall, as well as the unclaimed items auction conducted by the Sheriff's Office. This includes, but is not limited to, preparation of items for auction, publicizing the auctions, conducting the auctions, and ensuring the removal of items after the auctions. Teitsworth may also auction items at regional auctions, such as the Palmyra auction, and through periodic online auctions using their website. Items auctioned online are subject to a graduated scale buyer's premium in lieu of commission, with no cost to the County. The County has contracted with Teitsworth for these services for the last eighteen (18) years.

A request for proposals was issued for this contract and Roy Teitsworth, Inc. was selected as the most qualified to provide this service.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Roy Teitsworth, Inc., 6502 Barber Hill Road, Geneseo, New York 14454, to provide auctioneer services, for the period of September 1, 2017 through August 31, 2018, with the option to renew for two (2) additional one-year periods, with Roy Teitsworth, Inc. receiving 9% of auction proceeds to be deducted from the net proceeds from the sale of County equipment, and the County receiving proceeds in the amount of 10% of the commissions earned by Roy Teitsworth, Inc. from the sale of other Municipalities' equipment and the County receiving 5% of the commissions earned by Roy Teitsworth, Inc. from the sale of private sector sellers' equipment at auctions sponsored by Monroe County.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.
