Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Renew Their Commitment to Fully Funding the State Share of Community College

It is for certain that earning a college degree is both commendable and beneficial. It is helpful that under state law, funding for community colleges is to be provided through state aid, a county sponsor contribution, and student tuition and fees. These laws ensure that any student has the opportunity to attend community college if they chose to do so. Here in Monroe County, we are lucky to have one of the best community colleges in the nation, Monroe Community College.

The statewide community college system was based on an ongoing state aid funding commitment of at least one-third, and up to 40% of community college operating costs. However, the amount of state funding has decreased steadily over the years and is now below their one-third commitment, and well under 40%. While the Legislature and Governor Cuomo have been providing slight increases in state aid over the past few years, the increases remain well under the intended statutory commitment. Additionally, even with the modest increases in State aid, there has been a reduction in total aid provided.

Since 2008/2009 State Aid dollars to Monroe Community College have decreased steadily even though since 2011/2012 the State Aid Base Rate has increased. Even though the State Aid Base Rate has increased it has not made up for the difference in the decrease in State Aid dollars. At the same time, Monroe County's share and other local aid to Monroe Community College has steadily increased since 2009 while State aid for Community College has decreased drastically in the same time period. Monroe County taxpayers have stepped up and supported Monroe Community College. It is now time that Governor Andrew M. Cuomo and the New York State Legislature renew their financial commitment to community colleges. Therefore, I urge you to join me in calling on the New York State Legislature and Governor Andrew M. Cuomo to make every effort to increase state funding levels closer to 40% of the share for community college operating costs.

#### Honorable Legislators:

In a highly regulated and high taxed state like New York, it is imperative that counties have enough tools at their disposal to encourage economic growth. Industrial Development Agencies (IDAs) were created to facilitate economic growth in specific localities through attracting, retaining, and expanding businesses within their jurisdictions. By providing financial incentives to businesses, IDAs are a useful tool that county governments have at their disposal to provide residents with more employment and business opportunities.

However, legislation passed in 2008 restricted the ability of IDAs to provide loans, grants, and civic activity bonds. This legislation limited the amount that IDAs could invest to create workforce development programs, increase downtown revitalization, develop infrastructure, and create jobs. In addition to high taxes and overregulation, business now face another obstacle in keeping their doors open and expanding in New York State.

Senate Bill 6230A and Assembly Bill 8358 (not "same as" legislation) would authorize IDAs to provide loans, grants, and early-stage equity and seed funding within their jurisdictions to encourage businesses to locate in New York State, create jobs, and encourage economic growth. With an additional tool to incentivize businesses to locate here, counties in New York State can sustain a competitive economic environment, despite high taxes and regulations. Legislation passed in 2016 will ensure that IDAs will meet reporting requirements and remain transparent while awarding funds to businesses.

Therefore, I urge you to join me in calling on the New York State Senate and Assembly to Pass, and Governor Andrew M. Cuomo to Sign, Senate Bill 6230A and Assembly Bill 8358 to authorize IDAs to provide loans and grants to encourage economic growth in New York State.

Develop and Support a Consistent and Long Term Plan for Homelessness

Prevention in New York State

Honorable Legislators:

Finding solutions to homelessness continues to be a priority throughout New York State. While Governor Cuomo has been committed to alleviating the issue of homelessness, there are significant shortcomings in his attempts to find real and long term solutions to the problem of homelessness in New York State. Shifting the State's focus to permanent housing solutions and providing support to Counties will help to reduce homelessness and provide consistent and long term results for the homeless population in our area.

In recent years, there have been significant funding cuts by New York State that have restricted the ability of counties to pursue more aggressive homelessness prevention efforts. Monroe County Department of Human Services works hard to put into place what is mandated by the State. A more collaborative effort between New York State and local counties would provide more long term success in the prevention of homelessness. In addition, the focus on homelessness in the winter months tends to have unexpected consequences as many times there are different rules that are in place that in the long term end up hindering individuals from achieving permanent housing and stability.

The State must work with counties to prevent homelessness and develop long term solutions by focusing on permanent housing. Permanent housing is a cost-effective and successful way to reduce homelessness. New York State should work with local counties to develop a policy to maintain stability and prevent emergencies by being proactive in providing necessary resources up front. The implementation of permanent housing programs has been proven to decrease the number of chronically homeless individuals significantly. Research has also shown that in addition to reducing homelessness, permanent housing can increase housing stability and improve health and quality of life.

Therefore, I urge you to join me in calling on the New York State Legislature and Governor Andrew M. Cuomo to work with local governments to not only develop long term plans for the prevention of homelessness, but also assist in funding this plan. A collaborative effort between New York State and Counties to create a financially efficient and stable program for the homeless population will help to prevent homelessness moving forward and yield better results in our community. Shifting the focus of homelessness prevention and making the efforts to prevent homelessness more collaborative will help New York State's endeavors be more productive and successful.

Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Restore Funding Support for Unattended Death Investigations

#### Honorable Legislators:

The job of a coroner or a medical examiner is to make official inquiries concerning the cause and manner of an individual's death. Often times these deaths are found to be unnatural, unexplained, or suspicious, and with the recent surge of deaths from overdoses, county coroner and medical examiner offices have seen a drastic increase in toxicology tests. While these investigations and tests are extremely valuable to our communities, the cost falls directly on the counties, and in the case of Monroe County, our Medical Examiner's Office serves not just our county, but also twelve of our surrounding counties.

Prior to 2011, county coroners and medical examiners were reimbursed by New York State up to 36 percent due to Article 6 funding to local health departments. Unfortunately, in 2011, the NYS Budget shifted the reimbursement for medical examiners from the New York State Department of Health to the New York State Department of Criminal Justice Services; therefore, eliminating state funding to medical examiners because their work was now considered to be in the realm of public safety and not public health.

Counties all across New York State have been persistently advocating for the State to restore funding for coroners and medical examiners. This is a step that New York State must take in order to guarantee the fiscal solvency of these investigations as well as the county governments that are currently required to fund them. Additionally, by establishing a dedicated funding stream for coroners and medical examiners, the State can ensure that county medical examiner offices continue to function effectively and are given the flexibility to meet the needs of ever-changing trends.

Honorable Legislators,

Emergency Medical Service (EMS) agencies across New York State provide vital services to residents in crisis. Unfortunately, as non-participating or non-preferred providers, these important agencies often do not receive payment for their services. Instead, insurance payments are sent directly to the insured who keep the check rather than forwarding payment to the provider.

Both the NYS Senate and Assembly have had bills that address this issue, however they have been held in committee since 2009. These bills would authorize direct payments to non-participating or non-preferred providers of ambulance services licensed under Article 30 of the public health law. These are budget neutral bills and there is no cost to taxpayers.

EMS agencies are in danger of going out of business due to lack of funding and insufficient staffing, yet legislation that can help alleviate this situation and save vital services has languished in committee for nearly 10 years. Therefore, I ask you to join me in support of memorializing the NYS Senate and the NYS Assembly to Pass, and the President to Sign "AN ACT to Amend the Insurance law, in Relation to Payments to Prehospital Emergency Medical Services Providers".

### Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$87,000, for the Motor Vehicle Theft and Insurance Fraud Prosecution Program in the District Attorney's Office, for the period of January 1, 2019 through December 31, 2019.

This grant will fund a portion of the costs of one (1) full-time Assistant District Attorney to coordinate the efforts of the Rochester Police Department, New York State Insurance Department-Insurance Fraud Bureau, Monroe County Sheriff's Office, New York State Police, and other local police agencies in investigating cases involving auto theft, and insurance fraud involving motor vehicles.

The goals of the program include continuing to fully investigate and prosecute all suspected instances of motor vehicle theft in Monroe County, fully investigate and prosecute all individuals who file fraudulent motor vehicle theft claims, strengthening and expanding the information-sharing protocols among the various local police and State agencies investigating such crimes that were established during the program's first year, and to increase the arrest and conviction rate of the perpetrators of such crimes. ### Honorable Legislators:

I recommend that Your Honorable Body authorize the execution of Airline-Airport Use and Lease Agreements between the Monroe County Airport Authority ("MCAA") and any airline currently operating at the Airport, as well as any additional airline which may serve the Airport in the future, for a term commencing on January 1, 2019 and expiring December 31, 2023.

At the present time the MCAA has Airline-Airport Use and Lease Agreements, also known as Signatory Airline Agreements, with six (6) airlines that operate at the Airport. These agreements expire December 31, 2018.

The agreement is a modified compensatory agreement which means that MCAA establishes necessary airline rates and charges to cover the costs of facilities and airfield. Under the agreement, signatory airlines will be required to pay terminal rentals for lease of space in the airport terminal and aircraft landing fees, along with other miscellaneous fees associated with various airline operations as required. Non-signatory airlines will be charged a surcharge on the published signatory rates.

A public hearing is scheduled for November 7, 2018 and it is expected that the Monroe County Airport Authority will approve the Airline-Airport Use and Lease Agreement at its November 7, 2018 meeting.

### The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to execute an Airline-Airport Use and Lease Agreement, and any amendments thereto, between the Monroe County Airport Authority and any airline currently operating at the Airport, as well as any additional airline which may serve the Airport in the future, for a term commencing on January 1, 2019 and expiring December 31, 2023.

2. Authorize the County Executive, or her designee, to allocate or adjust leasable space with any signatory airline as may be appropriate and negotiated during the term of this agreement, and any renewals thereof.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Each agreement will be revenue generating to the Monroe County Airport Authority and no net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither of the airlines, nor any of their principal officers, owe any delinquent Monroe County property taxes.

I recommend that Your Honorable Body approve a request to establish an Increase and Improvement of Facilities in the Rochester Pure Waters District (District), in the amount of \$2,500,000, consisting of a capital project entitled the "General Collection System and Treatment Plant Improvements," and amend the proposed 2019 Capital Budget and authorize an appropriation transfer.

The total Increase and Improvement of Facilities in the District is comprised of the "General Collection System and Treatment Plant Improvements" project (\$2,500,000), the "Frank E. Van Lare Wastewater Treatment Plant Secondary Clarifier" project (\$4,000,000), the "Frank E. Van Lare Wastewater Treatment Plant Electrical System Improvements" project (\$2,500,000), and the "Frank E. Van Lare Wastewater Treatment Plant Aeration System Improvements" project (\$12,100,000), for a total estimated cost of the Increase and Improvement of Facilities in the amount of \$21,100,000. All of the above projects are under consideration by Your Honorable Body as companion referrals.

This increase and improvement of facilities is necessary to provide funding for the "General Collection System and Treatment Plant Improvements" project. This project includes general improvements to various pump stations, collection system infrastructure and the Frank E. Van Lare Wastewater Treatment Plant Secondary Clarifier Improvements," amend the proposed 2019 Capital Budget and Bond Resolution 63 of 2018.

The total Increase and Improvement of Facilities in the District is comprised of the "General Collection System and Treatment Plant Improvements" project (\$2,500,000), the "Frank E. Van Lare Wastewater Treatment Plant Secondary Clarifier" project (\$4,000,000), the "Frank E. Van Lare Wastewater Treatment Plant Electrical System Improvements" project (\$2,500,000), and the "Frank E. Van Lare Wastewater Treatment Plant Aeration System Improvements" project (\$12,100,000), for a total estimated cost of the Increase and Improvement of Facilities in the amount of \$21,100,000. All of the above projects are under consideration by Your Honorable Body as companion referrals.

This increase and improvement of facilities is necessary to provide additional funding for continuation of the "Frank E. Van Lare Wastewater Treatment Plant Secondary Clarifier Improvements" project. This project includes phased repair and replacement of the secondary clarifiers, including complete replacement of the internal mechanical systems and waste-activated sludge pumping system of each clarifier and associated upgrades to the electrical system and related site improvements. This project may be designed and documented as a green project and as a potential candidate for green bond financing.

The estimated cost of the improvements is \$5,000,000, with \$1,000,000 previously approved. The actual debt service obligation for the additional cost of the project, \$4,000,000, as projected in future years, could potentially result in an increase of \$2.33 to the future annual charges of the average District ratepayer. However, the actual impact is typically reduced through retirement of previous debt and other offsets to the District's capital charge levy. Based on an average water consumption of 60,000 gallons, the total annual charge for both operation & maintenance and capital to the typical District ratepayer in 2019 is \$235.70.

Portions of the project may become eligible for financing through the New York State Water Pollution Control Revolving Loan Fund. It is therefore requested that the County have the ability to submit applications and take any necessary steps to utilize this financing vehicle if it becomes available.

The specific Administrative Board action required is to submit a request to the Monroe County Legislature to approve an "Increase and Improvement of Facilities in the Rochester Pure Waters District" consisting of a capital project entitled "Frank E. Van Lare Wastewater Treatment Plant Secondary Clarifier Improvements," at an estimated cost of \$4,000,000, and amend the proposed 2019 Capital Budget and Bond Resolution 63 of 2018.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this project, consistent with authorized uses, will be available in capital fund 1891 once the additional financing authorization requested herein is approved and in any other capital fund(s) created for the same intended purpose. The local funding for this project will ultimately be provided by Pure Waters District user fees. No additional net County support is required in the current Monroe County budget.

I recommend that this matter receive favorable action by the Administrative Board of the Rochester Pure Waters District.

The escalations in collection costs during the term shall be subject to any increases or decreases in compactor rental rates and the solid waste tipping fees as set forth in Section D. of the intermunicipal agreement between the County of Monroe and City of Rochester (Resolution 261 of 2015) regarding Solid Waste Disposal and Recyclable Materials, dated November 30, 2015, and limit all other fee increases to a two percent per two year period.

I recommend that Your Honorable Body accept a grant from the New York State Governor's Traffic Safety Committee, in the amount of \$60,020, for the Comprehensive Toxicology Testing in Driving Under the Influence and Driving Under the Influence of Drugs Program, for the period of October 1, 2018 through September 30, 2019.

The purpose of this grant is to improve highway safety by expanding the forensic toxicology services provided by the Office of the Medical Examiner's Forensic Toxicology Laboratory ("Tox Lab") in alcohol and drugged driving impairment cases. The Tox Lab provides alcohol and comprehensive drug testing as well as expert testimony in driving impairment cases. It will also allow the Tox Lab to perform the research, method development and validation necessary to expand the scope of its drugged driving testing to include many of the new synthetic opioids and fentanyl analogs currently being widely abused and to analyze regional trends in drugged driving. In addition, the grant provides training funds to enhance the expertise of analysts when testifying regarding the effects of drugs on driving performance. This will be the seventh year the County has received this grant. This year's funding represents a decrease of \$43,730 from last year.

#### Honorable Legislators:

I recommend that Your Honorable Body authorize intermunicipal agreements with municipalities for Rochester-Monroe County Youth Bureau Programs related to the currently approved Child and Family Services Plan, in a total amount not to exceed \$189,525, for the period of January 1, 2019 through December 31, 2019. The list of municipalities, along with a description of the youth services each will provide, and the breakdown of funding to each, is in Attachment A.

The Rochester-Monroe County Youth Bureau enters into approximately twenty (20) intermunicipal agreements each year. New York State Office of Children and Family Services makes available recreation and youth services funds for all towns and villages via a pass through to local counties. Allocation ceilings are determined through a formula, based on the youth population of each town or village, provided by the state. The recreation and youth services programs to be provided are available to all youth that reside in the respective towns and villages. Recreational programs include a variety of athletic, social, artistic, and cultural events. Youth services programs include youth and family counseling, after-school programs, leadership development, and employment readiness workshops. This year's funding represents a decrease of \$1,634 from last year's funding.

Programs will be evaluated consistently and continually through three methods utilized by the Youth Bureau, documented in its Monitoring and Evaluation Systems Procedures Manual. These methods include: 1) self-report, requiring agency submission of three (3) different self-report instruments; 2) yearly outcome evaluation assessment of contract outcomes; and 3) expenditure review. These contracts will allow for the provision of a comprehensive range of youth services and programs by the municipalities specified in Attachment A.

#### The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to execute intermunicipal agreements, and any amendments thereto, with each municipality listed in Attachment A, for Rochester-Monroe County Youth Bureau Programs related to the currently approved Child and Family Services Plan, in a total amount not to exceed \$189,525, for the period of January 1, 2019 through December 31, 2019.
- 2. #### Honorable Legislators:

I recommend that Your Honorable Body authorize contracts with the agencies listed in Attachment A, in a total amount not to exceed \$733,524, for Rochester-Monroe County Youth Bureau programs, for the period of January 1, 2019 through December 31, 2019.

The Rochester Monroe County Youth Bureau enters into approximately ten (10) contracts each year in amounts over \$20,000, with matching funds required for Runaway and Homeless Youth providers only. Contracted services directly correspond to the assessed needs and service objectives of the Rochester-Monroe County Youth Bureau and as required and approved by the New York State Office of Children and Family Services. This year's funding represents an increase of \$15,598 from last year's funding.

The agencies were selected through a competitive request for qualifications process, based on the New York State required County Child and Family Services Plan in which services to be contracted must directly correspond to the assessed needs, priority focus areas, and outcomes of the plan; State Executive Law procedures and criteria for selecting programs; and State certification requirements for runaway and homeless shelter programs.

Contract programs will be evaluated consistently and continually through three methods utilized by the Youth Bureau, documented in its Monitoring and Evaluation Systems Procedures Manual. These methods include: 1) self-report, requiring agency submission of three (3) different self-report instruments; 2) yearly outcome evaluation assessment of contract outcomes; and 3) expenditure review. These contracts will allow for the provision of a comprehensive range of youth services and programs by the not-for-profit agencies specified in Attachment A.

Please refer to the attached Purchase of Services Information Form for disclosure of information required pursuant to Resolution 223 of 2007, as amended by Resolution 11 of 2008.

Subject: Authorize the Acquisition of a Portion of Property Located at 5353 St. Paul Street in the City of Rochester

Honorable Legislators:

I recommend that Your Honorable Body authorize the acquisition of a portion of property located at 5353 St. Paul Street in the City of Rochester, from the City of Rochester, for the purchase price of \$14,000.

The proposed acquisition is a portion of a 1.36-acre site improved by a one-story concrete block garage building ("Parent Parcel"). The proposed action is the purchase of a portion of the Parent Parcel, measuring approximately 25.01' wide by 46.31' totaling 1,158 sq.ft. improved with a portion of the building measuring 25' X 23' totaling 575 sq.ft. The proposed acquisition is for use by the Monroe County Sheriff's Office Marine Unit. Monroe County currently owns a portion of this building and through this purchase it will then own the entire building. The offered amount is based upon an appraisal prepared by Kevin L. Bruckner, MAI, a New York State certified general appraiser.

The specific legislative action required is to authorize the County Executive, or her designee, to acquire the property listed above at 5353 St. Paul Street in the City of Rochester, having tax identification number 047.56-2-5.1, from the City of Rochester, for the purchase price of \$14,000.

An environmental review will be completed for this acquisition prior to Your Honorable Body taking final action on this matter.

Funding for this acquisition is included in the 2018 operating budget of the Office of the Sheriff, general fund 9300, funds center 3803010000, Police Bureau Administration. No net County support is required in the current Monroe County budget.
