I recommend that Your Honorable Body authorize a contract with Bonadio & Co. LLP for independent auditing services of the County of Monroe's annual financial statements, plus any contractually agreed upon supplemental services, for the three (3) year period January 1, 2020 through December 31, 2022, in an amount not to exceed \$246,900 for the first year, \$253,550 for the second year and \$260,200 for the third year, with the option to extend for two (2) additional one-year periods.

The current agreement with Bonadio & Co. LLP, expires on December 31, 2019.

Services to be provided include a county-wide general purpose audit of financial statements in accordance with Government Auditing Standards, completion of Single Audit Reports required by the Federal Single Audit Act, completion of required state and federal institutional cost reports for Monroe Community Hospital, completion of the NYS DOT Single Audit Report, and preparation of all required communication letters to Your Honorable Body.

A request for proposals was issued for these contracts and Bonadio & Co. LLP was selected as the most qualified to provide the services.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Bonadio & Co. LLP, 171 Sully's Trail, Suite 201, Pittsford, New York 14534, for independent auditing services of the County of Monroe's annual financial statements, plus any contractually agreed upon supplemental services, for the three (3) year period January 1, 2020 through December 31, 2022, in an amount not to exceed \$246,900 for the first year, \$253,550 for the second year and \$260,200 for the third year, with the option to extend for two (2) additional one-year periods, in accordance with Section C2-6(C)(11), Section C6-5(C)(2)(d)(1) and Section C4-8(A) of the Monroe County Charter.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for the first year of this contract is included in the proposed 2020 operating budget of the Department of Finance, general fund 9001, funds center 1203010000, Controller Administration, and Monroe Community Hospital, hospital fund 9012, funds center 6201010000, MCH Administration, and will be requested in future years' budgets. No additional net county support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither Bonadio & Co. LLP, nor any of its principal officers, owe any delinquent property taxes.

RE: Authorizing the Creation of a Climate Action Plan Advisory Board

Honorable Legislators:

Monroe County has a long tradition of environmentally friendly initiatives and policies. However, we have stopped being a leader and have fallen behind as the effects of climate change have become more severe. As municipalities across the nation, and across Monroe County, have adopted climate action plans, we have yet to act.

Monroe County is not immune to the threats of climate change. If we don't act, we will see a rise in the prices of commodities like food, water, and building materials that will cause economic distress for our community. While many of the problems that lead to climate change require action and solutions at both the national and international levels, there is no doubt that what we do locally can have a positive impact.

This resolution would create an advisory board comprised of eleven members. Five will be current Monroe County Legislators (three majority members and two minority members) and six will be Monroe County residents (three to be recommended by the Majority Leader and three by the Minority Leader). The board will gather information from experts, constituents, and any other concerned parties to help outline the steps necessary to reduce, and possibly eliminate, the County's carbon footprint while developing a thriving and sustainable economy and report its

findings to the Legislature. This board will be able to identify and review practices and policies which may reduce municipal reliance on fossil fuels.

Our constituents have been encouraging us to take this action, and it time for us to do so. Therefore I urge you to authorize the creation of a climate action plan advisory board.

The specific legislative actions required are:

- 1. Adopt the resolution, as attached.
- 2. Create an advisory board as outlined in this proposed resolution.

This proposed resolution shall have no impact on the revenues and/or expenses of the current Monroe County Budget.

RESOLUTION NO	OF 2019

AUTHORIZING THE CREATION OF A MONROE COUNTY LEGISLATURE CLIMATE ACTION PLAN ADVISORY BOARD

BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

- Section 1. Pursuant to Section C2-4 (C)(5) of the Monroe County Charter, the Legislature hereby creates a Monroe County Legislature Climate Action Plan Advisory Board for the purpose of assisting the Legislature in developing a Climate Action plan. This plan will outline the steps necessary to reduce and possibly eliminate the County's carbon footprint while developing a thriving and sustainable economy and report its findings to the Legislature.
- Section 2. The Board shall be composed of eleven (11) people who are Monroe County residents and who shall be appointed by the President of the Legislature and confirmed by the Legislature in the following manner:
- 1. Five (5) shall be current members of the Monroe County Legislature, with three (3) recommended by the Majority Leader and two (2) recommended by the Minority Leader, and confirmed by the Legislature.
- 2. Six (6) shall be members of the community, all of whom shall reside within Monroe County, three (3) recommended by the Majority Leader and three (3) recommended by the Minority Leader, and confirmed by the Legislature.
- Section 3. In accordance with the goals set forth in Section 1, the Board shall, identify and review practices and policies which may reduce municipal reliance on fossil fuels, and identify any practices and policies which may reduce residential and commercial use of fossil fuels.
- Section 4. The Board shall report its findings and recommendations to the Monroe County Legislature no later than six months after this resolution takes effect.
- Section 5. This resolution shall take effect immediately.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$87,000, for the Motor Vehicle Theft and Insurance Fraud Prosecution Program in the District Attorney's Office, for the period of January 1, 2020 through December 31, 2020.

This grant will fund a portion of the costs of one (1) full-time Assistant District Attorney to coordinate the efforts of the Rochester Police Department, New York State Insurance Department-Insurance Fraud Bureau, Monroe County Sheriff's Office, New York State Police, and other local police agencies in investigating cases involving auto theft, and insurance fraud involving motor vehicles.

The goals of the program include continuing to fully investigate and prosecute all suspected instances of motor vehicle theft in Monroe County, fully investigate and prosecute all individuals who file fraudulent motor vehicle theft claims, strengthening and expanding the information-sharing protocols among the various local police and State agencies investigating such crimes that were established during the program's first year, and to increase the arrest and conviction rate of the perpetrators of such crimes. This will be the seventeenth year the County has received this grant. This year's funding is the same amount received in last year's award.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept an \$87,000 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Motor Vehicle Theft and Insurance Fraud Prosecution Program, for the period of January 1, 2020 through December 31, 2020.
- 2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this grant is included in the proposed 2020 operating budget of the District Attorney's Office, general fund 9300, funds center 2507010000, Non-Violent Felony Bureau.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$208,000, for the Crimes Against Revenue Program in the District Attorney's Office, for the period of January 1, 2020 through December 31, 2020.

This grant will provide funding to support a portion of the cost of three (3) full-time Assistant District Attorneys, and one (1) full-time clerical support position. The Assistant District Attorneys will investigate and prosecute individuals and businesses operating in Monroe County that violate tax laws, recoup revenue lost due to non-compliance, and to increase voluntary compliance with applicable tax laws. In addition to crimes involving failure to collect, report, and pay New York State taxes involving welfare benefits, unemployment insurance benefits and workers' compensation payments will also be investigated and prosecuted by program staff. This will be the fifteenth year the County has received this grant. This year's funding is the same amount received in last year's award.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$208,000 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Crimes Against Revenue Program in the District Attorney's Office, for the period of January 1, 2020 through December 31, 2020.

- 2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any encumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley and Monroe County Public Defender Timothy Donaher.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$633,768, for the Aid to Localities (ATL) Program, for the Offices of the District Attorney and the Public Defender, for the period of October 1, 2019 through September 30, 2020.

The ATL Grant program provides expedited felony case processing through the judicial system by funding part or all of the salary costs equivalent to five (5) full-time positions in the District Attorney's Office, and part of the salary costs of six (6) full-time positions in the Public Defender's Office. We have been notified of the funding amounts for the District Attorney, \$395,739, and the Public Defender, \$238,029. This will be the thirty-seventh year the County has received this grant. This year's funding represents a decrease of \$21,171 for the Public Defender's Office over the last twelve month period.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$633,768 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Aid to Localities Program, for the Offices of the District Attorney and the Public Defender, for the period of October 1, 2019 through September 30, 2020.

- 2. Amend the 2019 operating budget of the District Attorney's Office by appropriating the sum of \$395,739 into general fund 9300, funds center 2508010000, Major Felony Bureau.
- 3. Amend the 2019 operating budget of the Public Defender's Office by appropriating the sum of \$238,029 into general fund 9300, funds center 2601010000, Office of The Public Defender.
- 4. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 5. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Office of Indigent Legal Services, in the amount of \$1,592,379, for the Office of the Monroe County Public Defender and the Office of the Monroe County Conflict Defender, for the provision of indigent legal services, for the period of January 1, 2019 through December 31, 2021.

The Office of the Public Defender will use the funding for part or all of the salary costs equivalent to eight (8) existing full-time Assistant Public Defender positions and one (1) paralegal as well as expert services, commercial services and training costs. The Office of the Conflict Defender will use the funding for part or all of the salary costs equivalent to three (3) existing Office Clerk positions as well as expert services, computer equipment and training costs. We have been notified of the funding amounts for the Office of the Monroe County Public Defender (\$1,201,950), and the Office of the Monroe County Conflict Defender (\$390,429) over a three (3) year period. This is the ninth year the County has received this grant. This year's funding represents the same amount as the last time the County received this grant.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$1,592,379 grant from, and to execute a contract and any amendments thereto with, the New York State Office of Indigent Legal Services, for the Office of the Monroe County Public Defender and the Office of the Monroe County Conflict Defender, for the provision of indigent legal services, for the period of January 1, 2019 through December 31, 2021.
- 2. Amend the 2019 operating budget of the Office of the Public Defender by appropriating the sum of \$400,650, into general fund 9300, funds center 2601010000, Public Defender Administration.

- 3. Amend the 2019 operating budget of the Department of Public Safety by appropriating the sum of \$130,143 into general fund 9300, funds center 2402010000, Legal Representation.
- 4. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 5. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$103,860, for the Monroe County Public Defender's Mental Health and Drug Treatment Court Program, for the period of July 1, 2017 through June 30, 2018.

This is a continuation of a New York State initiative, funded by federal funds under the Edward Byrnes Memorial Justice Assistance Grant, to subsidize the legal representation of indigent defendants who are chemically dependent and accused of nonviolent felonies and felony violations of probation. The grant assists with the salary of four (4) existing Assistant Public Defender positions. This is the twenty-fifth time that the County has received this grant. This year's funding represents no change from the last time the grant was received.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$103,860 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Monroe County Public Defender's Mental Health and Drug Treatment Court Program, for the period of July 1, 2017 through June 30, 2018.
- 2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Todd K. Baxter.

I recommend that Your Honorable Body accept a grant from the United States Department of Justice, Drug Enforcement Administration (DEA), in an amount not to exceed \$18,649, for the reimbursement of overtime for the DEA Task Force, for the period of October 1, 2019 through September 30, 2020.

This grant will support a collaborative task force with the DEA to investigate, apprehend and arrest narcotic traffickers. The grant will reimburse overtime costs associated with the task force services. This will be the second year the County has received this grant. This year's funding represents an increase of \$305 from last year.

The specific legislative actions required are:

- 1. Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Fluent Consulting Corporation (Fluent) for the provision of energy aggregation group management services for Monroe County ("County"), for the period of January 1, 2020 through December 31, 2020, with the option to renew for two (2) additional one-year periods upon mutual agreement of the parties. The cost to Monroe County will be \$0.00065 per kilowatt-hour (kWh) of electricity and \$0.075 per decatherm (Dth) of natural gas.

Since 2001, the County has been authorized by the New York State Public Service Commission to operate as a municipal Energy Services Company (ESCo), which allows the County to procure natural gas and electricity for itself and members of a municipal energy aggregation group that currently includes seventeen (17) towns and villages, one school district, two Fire Districts, the Monroe County Water Authority and the Rochester Genesce Regional Transit Authority. The energy aggregation group currently has over 1,400 accounts, about 600 of which belong to the County.

As part of this contract, Fluent will also monitor and schedule the daily nominations related to the County's natural gas and electric accounts as well as its aggregation pools to ensure that an adequate supply of reliable electricity and natural gas is delivered at the most cost-effective rate. Fluent will also provide back office accounting and invoicing support for the County and the aggregation group, as well as utility bill and tariff analysis on behalf of the ESCo to ensure proper billing. The rates are \$0.00065 per kilowatt-hour (kWh) of electricity and \$0.075 per decatherm (Dth) of natural gas. The cost to the County, based on the current energy usage and number of accounts, will be approximately \$99,000 per year.

Fluent has performed this service for the County for almost twenty years. A request for proposals was issued for this contract and Fluent was selected as the most qualified to provide these services.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Fluent Consulting Corporation, 325 Delaware Avenue, Suite 210, Buffalo, New York 14202, to provide energy aggregation group management services for Monroe County, for the period of January 1, 2020 through December 31, 2020, with the option to renew for two (2) additional one-year periods upon mutual agreement of the parties. The cost to Monroe County will be \$0.00065 per kilowatt-hour (kWh) of electricity and \$0.075 per decatherm (Dth) of natural gas.

Honorable Legislators:

I recommend that Your Honorable Body authorize an intermunicipal agreement with municipal corporations to authorize the continued operation of the Stormwater Coalition of Monroe County, for the period of January 1, 2020 through December 31, 2024, with the option to renew for three (3) additional five-year terms.

Per Resolutions 226 of 2004, 314 of 2009, and 449 of 2014, Your Honorable Body authorized intermunicipal agreements with municipal corporations to reduce stormwater pollution and protect water quality in Monroe County and to comply with Federal Phase II Stormwater Regulations set forth by the United States Environmental Protection Agency and the New York State Department of Environmental Conservation.

The Coalition's purpose is to: work collaboratively to facilitate compliance with the New York State MS4 General Permit requirements; reduce stormwater pollution and improve water quality; and facilitate the use of existing or future resources, organizations and programs to meet the regulatory and environmental goals.

The Coalition members contribute an annual base fee and supplemental fee. The base fee is \$5,000 for regulated towns, \$2,500 for regulated villages, \$2,000 for non-regulated towns, and \$1,250 for non-regulated villages. The supplemental fee is based on population data obtained from the 2010 census and is calculated as \$0.14 per resident for all regulated Coalition members. The County provides staff and other in-kind services in lieu of paying a fee.

Authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with municipal corporations, to authorize the work of the Stormwater Coalition of Monroe County, for the period of January 1, 2020 through December 31, 2024, with the option to renew for three (3) additional five-year terms.

This project involves widening on Ridgeway Avenue and adding a center two-way left turn lane and construction of a dedicated westbound right turn only lane on Ridgeway Avenue at Erie Canal Commons Plaza. The work involves: milling & resurfacing of pavement surface, replacement of section of existing sidewalk/curb, installation of closed drainage pipes and catch basins, installation of traffic signal loops, installation of new traffic signage, adjusting catch basins to grade, and pavement marking installations. There are currently insufficient funds available for the project due to design and construction costs being higher than was expected when the funding application was submitted. The total estimated project cost is now \$1,045,000.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the New York State Department of Transportation, for the Highway Lighting Rehabilitation North Project in the City of Rochester and Town of Irondequoit.

The project involves the rehabilitation of the Highway Lighting on NY Route 104 between the Genesee River in the City of Rochester and Town of Irondequoit. The project will involve the replacement of some lighting poles, lighting conduit systems and electrical wires, as well as upgrade of the system to LED lights. The current total project estimate is \$4,150,000.

Major funding will be provided by Federal and New York State Marchiselli funds in the amount of approximately 95% of the project cost with overall project administration by Monroe County.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the New York State Department of Transportation, for the Highway Lighting Rehabilitation North Project in the City of Rochester and Town of Irondequoit.
- 2. Incorporate by reference and adopt the attached resolution required by New York State for the Highway Lighting Rehabilitation North Project.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

As municipal representatives, Cathy Dewey-Napier, William Hawkins, Paul DiStefano and any other qualified individual will represent the County of Monroe as its designees to school district Committees on Preschool Special Education (CPSE) as authorized by Section 4410 of the NYS Education Law as amended and Part 200 of the Regulations of the Commissioner of Education. The municipal representative is a voting member of each committee in determining initial and continuing eligibility for Preschool Special Education services at the least restrictive environment appropriate to a child's needs.

Requests for Qualifications were issued for these contracts and Cathy Dewey-Napier and William Hawkins were selected as the most qualified to provide this service. Paul DiStefano replaced a retired municipal representative mid-year. Any additional municipal representative would need to meet the qualifications outlined in the previously released Requests for Qualifications.

I recommend that Your Honorable Body accept a grant from the United States Department of Justice, National Institute of Justice, in the amount of \$183,108, for the Strengthening the Medical Examiner – Coroner System Program, for the period of January 1, 2020 through December 31, 2021.

The purpose of this grant is to improve the quality and timeliness of forensic science services and ensure the capabilities of OME personnel. Funds will be used to combat the existing case backlog and to ensure that staff maintains the necessary knowledge and skills to accomplish required work consistent with generally accepted practices. The grant will cover travel costs to send OME staff to advanced training courses and professional meetings and obtain necessary staff certifications. Additionally, there are monies designated to contract with consulting forensic pathologists to assist the OME in reducing case backlog. This will be the first year the County has received this grant.

The specific legislative actions required are:

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Governor's Traffic Safety Committee, in the amount of \$59,670, for the Comprehensive Toxicology Testing in Driving Under the Influence and Driving Under the Influence of Drugs Program, for the period of October 1, 2019 through September 30, 2020.

The purpose of this grant is to improve highway safety by expanding the forensic toxicology services provided by the Office of the Medical Examiner's Forensic Toxicology Laboratory ("Tox Lab") in alcohol and drugged driving impairment cases. The Tox Lab provides alcohol and comprehensive drug testing as well as expert testimony in driving impairment cases. It will also allow the Tox Lab to perform the research, method development and validation necessary to expand the scope of its drugged driving testing to include many of the new synthetic opioids and fentanyl analogs currently being widely abused and to analyze regional trends in drugged driving. In addition, the grant provides training funds to enhance the expertise of analysts when testifying regarding the effects of drugs on driving performance. This will be the eighth year the County has received this grant. This year's funding represents a decrease of \$350 from last year.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$59,670 grant from, and to execute a contract and any amendments thereto with, the New York State Governor's Traffic Safety Committee, for the Comprehensive Toxicology Testing in Driving Under the Influence and Driving Under the Influence of Drugs Program, for the period of October 1, 2019 through September 30, 2020.
- 2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

I recommend that Your Honorable Body authorize intermunicipal agreements with municipalities for Rochester-Monroe County Youth Bureau Programs related to the currently approved Child and Family Services Plan, in a total amount not to exceed \$184,056, for the period of January 1, 2020 through December 31, 2020. The list of municipalities, along with a description of the youth services each will provide, and the breakdown of funding to each, is in Attachment A.

The Rochester-Monroe County Youth Bureau enters into approximately twenty (20) intermunicipal agreements each year. New York State Office of Children and Family Services makes available recreation and youth services funds for all towns and villages via a pass through to local counties. Allocation ceilings are determined through a formula, based on the youth population of each town or village, provided by the state. The recreation and youth services programs to be provided are available to all youth that reside in the respective towns and villages. Recreational programs include a variety of athletic, social, artistic, and cultural events. Youth services programs include youth and family counseling, after-school programs, leadership development, and employment readiness workshops. This year's funding represents a decrease of \$5,469 from last year's funding.

Programs will be evaluated consistently and continually through three methods utilized by the Youth Bureau, documented in its Monitoring and Evaluation Systems Procedures Manual. These methods include: 1) self-report, requiring agency submission of three (3) different self-report instruments; 2) yearly outcome evaluation assessment of contract outcomes; and 3) expenditure review. These contracts will allow for the provision of a comprehensive range of youth services and programs by the municipalities specified in Attachment A.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to execute intermunicipal agreements, and any amendments thereto, with each municipality listed in Attachment A, for Rochester-Monroe County Youth Bureau Programs related to the currently approved Child and Family Services Plan, in a total amount not to exceed \$184,056, for the period of January 1, 2020 through December 31, 2020.
- 2. MUNICIPALITIES CONTRACTS 2020

1. Town of Brighton

\$7,085

This program works with teens in the community to develop and implement the Brighton asset building initiative. A Youth Board will work throughout the community in promoting awareness, support and opportunities for asset building in Brighton. The Youth Board, under the direction of the recreation supervisor, will work closely with Brighton Asset Network in developing and achieving this initiative.

2. Town of Chili

\$6,118

This program is designed to promote the constructive use of leisure time to address youth problems in our community. Opportunities for youth, ages 10-19, to participate in leisure and social activities are provided throughout the year.

3. Village of East Rochester

\$1,409

To provide homework assistance, tutoring, and education presentations. Youth are provided opportunities to become involved in community service projects and leadership development through the East Rochester Youth Activity Center. .

4. Town of Greece

\$38,345

The programs provide youth under 21 years of age with recreational, social, educational, physical, and self-help opportunities to help mold them into responsible young adults, including diversion program to divert youth from Family Court and a counseling program for the general youth population.

5. Town of Hamlin

\$2,101

To serve youth from ages 18 months to 16 years on how to get along and work with others of all ages through play group, playground and youth groups. These programs offer social, education, leisure and community service opportunities.

6. Town of Henrietta

\$23,413

Services for youth, age 20 and under (and their families), who are experiencing problems in the areas of relationships, communication, personal, career planning, and substance abuse. Youth will be referred by schools, family, community sources and word of mouth. Services will primarily be individual and group counseling experiences, including recreational activities for youth and families. Programs include arts and crafts, field trips, educational activities, special events and youth/adult partnership opportunities.

7. Town of Irondequoit

\$9,689

The program serves juveniles with police contact in the Town of Irondequoit and assists in preventing juvenile delinquency. Specialized programs, counseling and referrals to appropriate agencies are used to reach the primary goal of diversion from the juvenile system, supervised summer playground through town recreation.

8. Town of Hilton-Parma \$3,458

The program will provide year round recreational activities, both active and passive, for school age youth including: individual sports, team sports, instructional programs and open drop-in type programs.

9. Town of Penfield \$7,550

The Penfield Recreation Department will provide a creative and constructive program of leisure time activities and asset building opportunities to aid in the positive mental and physical development of the town's youth population.

10. Town of Perinton \$8,909

A comprehensive youth services program offered to youth 20 and under that are residents of Perinton. Programs require a registration form or sign-in, depending on the activity, and include youth-adult partnership opportunities; adventure based programming, social competency development groups and recreation opportunities.

11. Town of Pittsford \$7,309

Pittsford Youth Services, Inc. is a private, not-for-profit agency, providing crisis intervention, counseling, prevention programming, information and referral services to Pittsford youth and families. Examples of concerns youth bring to the agency include drug and alcohol abuse, school problems, depression/suicide, and family and peer relationships. This program also provides crisis intervention, counseling, prevention programming, information and referral services to Pittsford youth and families. Such services include drug and alcohol abuse, school problems, depression/suicide, and family and peer relationships. This is a joint program with the Village of Pittsford.

12. Town of Riga \$784

Provide a year round recreation program to youth, ages up to 20, in the Riga area. Athletics, aquatics, art and special event programs will be offered. Participants will meet new people, experience new activities and enjoy constructive use of leisure time.

13. Town of Sweden \$5,591

This is a joint program with the Town of Sweden, Town of Clarkson and Village of Brockport. The program provides a variety of recreational events for youth and their families to give youth a sense of community and to build and enhance developmental assets.

14. Town of Webster \$7,994

To provide after-school activities that promotes health lifestyles. These programs include development of recreational, problem-solving and social skills. Leadership development is also offered through a youth volunteer program.

15. City of Rochester \$54,301

Prepare youth for economic success and encourage improved academic success through BIZ Kids I and II, which involves them in junior achievement type opportunities. Youth Councils at each of the twelve major City Recreation sites develop leadership skills in youth. Youth provided with life-long learning experiences, future career expectations and employment potential through the Junior Recreation program.

Honorable Legislators:

I recommend that Your Honorable Body amend the 2019 Capital Budget and Bond Resolution 238 of 2018 to provide an increase in funding for the South Taxiway - Runway 10-28 Project at the Greater Rochester International Airport.

This project will create a new 2,500 foot segment of east/west taxiway for Runway 10-28, south of the runway, including upgrading of the intersected pavements at Taxiway H and Taxiway F. This taxiway will align with Taxiway P, which starts at Taxiway F and connects to the Runway 28 Threshold. This project will also include work required on Federal Aviation Administration owned navigation facilities.

The consultant completed the environmental assessment and coordinated program requirements to satisfy the Federal Aviation Administration for this important project. The budget used initially to create the capital account 1896 will not be adequate to complete the project.

This project will be funded by a Federal Aviation Administration grant of 90%, a New York State Department of Transportation grant of 5%, and a local share of 5%.

The specific legislative actions required are:

1. Amend the 2019 Capital Budget to increase funding for the South Taxiway - Runway 10-28 Project at the Greater Rochester International Airport, in the amount of \$1,000,000 from \$4,000,000 to \$5,000,000, for a total project authorization of \$5,000,000.

2. Amend Bond Resolution 238 of 2018 to increase financing for the South Taxiway - Runway 10-28 Project at the Greater Rochester International Airport, capital fund 1896, in the amount of \$1,000,000, from \$4,000,000 to \$5,000,000, for a total project authorization of \$5,000,000.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this project, consistent with authorized uses, will be available in capital fund 1896 once the additional financing authorization requested herein is approved and in any capital fund(s) created for the same intended purpose. The local funding for this project will ultimately be provided by the Monroe County Airport Authority from Airport generated revenues. No net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 216 of 2019 to rescind Section 3 to incorporate by reference and adopt the attached resolution required by the New York State Department of Transportation for Bridge NY Funding for the Culverts NY project (Ayrault Road Culvert over Irondequoit Creek Tributary) in the Town of Perinton.

The Ayrault Road Culvert is County-owned and spans Irondequoit Creek Tributary in the Town of Perinton. The project involves the rehabilitation or replacement of the Culvert, along with highway approach and channel improvements. The current total project estimate is \$965,000.

Major funding will be provided by New York State Department of Transportation funds in the amount of approximately 100% of the project cost with overall project administration by Monroe County.

Monroe County was awarded Federal funding for this project through the Bridge NY program. New York State requires that construction of the project begin no later than twenty-four (24) months after award and that the construction phase of the project be completed within thirty (30) months.

Pursuant to Resolution 216 of 2019, Your Honorable Body incorporated and adopted a New York State resolution to secure Bridge NY funding for the project. The State Resolution stated incorrectly that the time period required for completing the project was three years. Under State law, the time period required for completing the project is two and one-half years (thirty months). I recommend that Your Honorable Body authorize a contract with Ultramobile Imaging, Inc., in an amount not to exceed \$300,000, to provide radiology services for residents at Monroe Community Hospital (MCH), for the period of October 1, 2019 through September 30, 2022, with the option to renew for two (2) additional one-year terms, in an amount not to exceed \$100,000 per year.

The residents of MCH benefit from on-site exams and procedures, rather than having to be transferred out of the building to another service provider. Radiology services to be provided to MCH include routine x-ray examinations, ultrasounds, vascular imaging, carotid imaging and echocardiography. Most exams are scheduled approximately 24 hours in advance, however, there is a requirement for STAT procedures 24-hours/day, 7-days/week. The vendor shall utilize state-of-the-art equipment, transport of such to and from MCH, as well as the set-up and dismantling necessary to administer on-site.

A Request for Proposals was issued for this contract and Ultramobile Imaging, Inc. was selected as the most qualified to provide this service.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Office of Children and Family Services (OCFS), in the amount of \$43,350 for the Safe Harbour Initiative for 2020 (Safe Harbour), for the period of January 1, 2020 through December 31, 2020.

This award will be used to continue the established efforts of Safe Harbour such as short-term safe housing that offers 24-hour crisis intervention, medical care, advocacy, and other services to minor victims of human trafficking within Monroe County. The Center for Youth Services will continue to be the lead agency for this grant after its demonstrated successful collaboration with Monroe County during the partnership's 5 year pilot program, and successive years of "NYS Graduate Community" status. Monroe County has been recognized as a statewide leader with Safe Harbour and has shared its successes with new piloting counties. The Monroe County Department of Human Services will continue to assign the Rochester-Monroe County Youth Bureau Executive Director to be its representative who will serve as County liaison to the OCFS Statewide Steering Committee and to provide inter-agency collaborative support and guidance for sustainable implementation of the Safe Harbour Plan. Training will be provided to teach the skills and tools necessary to ensure that child victims are properly identified, referred and receive the appropriate specialized services to which they are entitled by law. This is the eighth year the County has received this grant.

The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$43,350 grant from, and to execute a contract and any amendments thereto with, the New York State Office of Children and Family Services, for the Safe Harbour Initiative for 2020, for the period of January 1, 2020 through December 31, 2020.
- Amend the proposed 2020 operating budget of the Department of Human Services, Division of Social Services, by appropriating the sum of \$43,350 into fund 9300, funds center 5118010000, Social Service Grants.

- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreements affecting such positions.
