

Re: Memorializing Governor Andrew M. Cuomo, and the New York State Legislature to Increase Reimbursement Rates for Early Intervention in the 2020-2021 New York State Budget and to Honor the 2019-2020 5% Rate Increase

Honorable Legislators:

The first five years of a child's life are important for long-term cognitive and behavioral development – especially for children with special needs. Many doctors and professionals refer to this time period as irreplaceable, because the progress a child can make before age five simply can't be replicated later in life.

For over a year, this Honorable Body has heard monthly from parents, advocates and providers about the crisis facing Early Intervention. A crisis that is the result of a broken statemandated rate structure that has forced providers out of business. Fewer providers mean less service coordinators and service providers.

In response to strong advocacy from Monroe County and advocates, New York State adopted, via the 2019-2020 State Budget, a 5-percent early intervention rate increase for approved rehabilitation services rendered by licensed speech language pathologists, licensed occupational therapists and licensed physical therapists, including supplemental evaluation services. To date, the promised increased has yet to be enacted.

Although Monroe County has no control over the rates for Early Intervention, there is local control over certain rates pertaining to Pre-School Special Education. Last year, Monroe County raised the County-set reimbursement rates by 15-percent, representing the first adjustment to the local Preschool Special Education rate structure in a decade.

New York State must follow Monroe County's lead and prioritize Early Intervention through increased reimbursement rates. Increased rates will reattract providers and improve provider capacity. Therefore, we call upon Governor Andrew M. Cuomo and the New York State Legislature to follow Monroe County's lead to honor the 2019-2020 rate increase and include additional rate increases in the 2020-2021 Budget to equal a 15-percent rate increase for all categories of services within Early Intervention.

Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Repeal Newly Enacted Bail Reform Laws

Honorable Legislators:

New York State's bail reform law took effect on January 1, 2020 and what ensued was nothing less than disastrous. From compelling judges to release thousands of arrested defendants, many of whom committed violent crimes, to prohibiting arraignment judges from setting bail for certain defendants. These bail reforms laws allow felonies such as certain aggravated assaults on children, aggravated harassments, prisoners escapes, rapes, riots, robberies and vehicular manslaughter to go without bail or jail-time.

In New York City, a women charged with an anti-Semitic attack was arrested and released three times in five days after assaulting three Jewish women. In Albany, a man charged with second degree manslaughter in connection to the murder of an Albany woman was released from jail after the judge cited bail reform as preventing custody. In Rochester, the man convicted of shooting Rochester Police officer Anthony DiPonzio was released without bail for new drug offenses. In Fairport, a man was released without bail after he used a loaded shotgun to threaten the life of a victim, only to be rearrested for the same crime later that day.

In our largest city, to our State capital, to our own backyards, bail reform has left our communities less safe and more dangerous. These disastrous impacts will continue every second this flawed law remains in place. It is incumbent upon all elected officials to oppose and fight for the removal of this law.

Laws are meant to improve the common-good and welfare of all people. The State's newly enacted bail reform laws fail to meet this criterion. Therefore, I urge you to join me in calling upon the New York State Legislature and Governor Andrew M. Cuomo to repeal the newly enacted bail reform laws.

Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Repeal the Reproductive Health Act (RHA)

Honorable Legislators:

On January 22, 2019, the Reproductive Health Act (RHA) was passed by the New York State Legislature and was signed into law by Governor Andrew Cuomo. New York State law previously allowed abortions after twenty-four weeks (late-term abortions) only when they were necessary to save the woman's life. Under the RHA, late-term abortions are now permitted anytime throughout the pregnancy when necessary to protect the woman's health. Unfortunately, there is not a clear definition of what constitutes "health" when determining what is an acceptable reason for a late term abortion. In some cases, things as simple as stress, discomfort, or inconvenience can be interpreted as health concerns that could be used as a reason to have a late-term abortion.

Through the implementation of the RHA, NY Public Health Law 4164 was repealed. This law protected the lives of children born during abortions. Live births sometimes occur as a result of abortion attempts. NY Public Health Law 4164 required that infants born in an abortion attempt receive the full protection of the law and must receive the same immediate medical treatment that any other child born would receive, by a physician other than the physician performing the abortion. By repealing this law, infants born during an abortion can legally be allowed to die without any medical attempt to help them. This act makes legal the cruel and inhumane treatment of the unborn and infants born in abortion attempts.

The RHA opens the door broadly for potential medical abuse by allowing any health care practitioner – not just physicians – to perform an abortion as long as he or she acts in "good faith," rather than acting according to an objective medical standard of care. The RHA repealed a section of New York's Public Health Law that required abortions to be performed after twelve weeks of pregnancy to be performed in a hospital setting by a licensed physician.

The RHA also removed abortion-related crimes from the Penal Law, including violent criminal acts that injure or kill pre-born children. This means if a pregnant woman is assaulted and killed, the assailant cannot be charged with the death of the unborn child. Even if the woman is not killed but the attack results in the death of the unborn child, the assailant cannot be charged for its death.

Therefore, for the above reasons, we urge you to join us in calling on the New York State Legislature and Governor Andrew M. Cuomo to repeal the Reproductive Health Act.

Authorize the Initiation of the Process for Making Additions to Monroe County

Agricultural Districts

Honorable Legislators:

I recommend that Your Honorable Body authorize the initiation of the process for making additions to Monroe County's Agricultural Districts.

Section 303-b of the Agriculture and Markets Law requires Your Honorable Body establish an annual 30-day period during which landowners can submit proposals to include land that is predominantly viable agricultural land within a certified agricultural district. Monroe County would begin this addition process by publishing a general notice to make landowners aware of the 30-day submission period. At the end of the 30-day submission period all requests for inclusion will be referred to the Monroe County Agricultural and Farmland Protection Board (AFPB) for its recommendations. The AFPB then has 30 days to make a recommendation to Your Honorable Body concerning any proposed additions to the state-certified agricultural districts. Upon receipt of the recommendation, Your Honorable Body must hold a public hearing before taking action to adopt or reject the addition of any parcels to any district. A second referral will be submitted to Your Honorable Body after the report of the AFPB to schedule the public hearing and recommend adoption or rejection of the addition of parcels to any district.

The specific legislative actions required are:

1. Authorize the Clerk of the Legislature to publish and post notice of the 30-day submission period for requests to include land, which is predominantly viable agricultural land, within state-certified Monroe County agricultural districts.

2. Direct the Monroe County Agricultural and Farmland Protection Board to prepare and submit a report, within 30-days of the termination of the submission period, with its recommendations as to whether inclusion of each piece of land proposed to be included in the certified agricultural districts a) consists predominantly of viable agricultural land and b) would serve the public interest by assisting in maintaining a viable agricultural industry within the certified agricultural districts.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This initiation of process will have no impact on the revenues or expenditures of the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Authorize an Intermunicipal Agreement with the Churchville-Chili Central School District for Reimbursement to the Monroe County Sheriff's Office School Resource

Program and Create a New Deputy Sheriff Position

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Todd K. Baxter.

I recommend that Your Honorable Body authorize an intermunicipal agreement with Churchville-Chili Central School District, in an amount not to exceed \$63,000, for reimbursement to the Monroe County Sheriff's Office School Resource Program, for the period of January 6, 2020 through June 30, 2020, and to increase the Table of Organization of the Sheriff's Office by creating one (1) Deputy Sheriff position, Group 70.

Churchville-Chili Central School District will be provided a full-time Monroe County Sheriff's School Resource Officer ("SRO") during the remaining 110-day school year, plus an additional 8 administrative days and overtime deemed necessary by the request and approval of the District and Sheriff's Office. The SRO's primary duty is to promote an atmosphere where students, teachers and staff feel safe. The SRO may assist in the investigation of suspected criminal activity occurring on Churchville-Chili Central School District. This assistance shall be provided in consultation with school administrators, in accordance with New York State Law and Churchville-Chili Central School District policy. As an educator, working with classroom teachers and other Churchville-Chili Central School District personnel, the SRO may present information and answer questions on a variety of topics, such as the law, drugs, safety, crime prevention, and violence prevention, concepts of safety, traffic laws, general law, and crime prevention techniques. The goal of the presentations is to increase student, staff, and community awareness and understanding of laws and personal safety. The SRO shall also perform such other security and/or law enforcement services as may be reasonably assigned by the District Superintendent, in consultation with the Sheriff, as appropriate.

The District will fund the salary and fringes associated with the Sheriff's Office SRO assigned during the 110 day school year, plus an additional 8 administrative days.

The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to execute an intermunicipal agreement, and any amendments thereto, with Churchville-Chili Central School District, in an amount not to exceed \$63,000, for reimbursement to the Monroe County Sheriff's School Resource Program, for the period of January 6, 2020 through June 30, 2020, and to increase the Table of Organization of the Sheriff's Office by creating one (1) Deputy Sheriff position, Group 70.
- 2. Amend the 2020 operating budget of the Sheriff's Office by appropriating the sum of \$63,000 into general fund 9001, funds center 3803010000, Police Bureau Administration.
- 3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This agreement is revenue generating and no additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

I recommend that Your Honorable Body authorize a contract with the University of Rochester, in an amount not to exceed \$120,000, for a Monroe County Emergency Medical Services (EMS) Medical Director, for the period of January 1, 2020 through December 31, 2020, with the option to renew for one (1) additional one-year term, in an amount not to exceed \$120,000 per year.

The Monroe County EMS Medical Director reports to the Director of Public Safety. The Director's services will be provided to the following agencies and County Departments: Monroe County Fire Departments, Monroe County EMS Agencies, Monroe County Sheriff's Department and the Monroe County 911 Center. The EMS Medical Director's services will include, but not be limited to:

- Help establish medical policy for pre-hospital care and operations of EMS in Monroe County.
- Work with the Public Safety Department and the EMS Office on special projects including but not limited to: data collection and analysis, special projects such as the 911 CAD and Records Management System project and others yet to be determined.
- Provide medical direction and oversight for the Emergency Medical Dispatch (EMD) Program at the Monroe County/City of Rochester Emergency Communications Department (911 Center).
- Provide medical direction for the Public Access Defibrillation Program for all Automated External Defibrillators (AEDs) owned/maintained by the County of Monroe.
- Provide medical direction and oversight for all County-maintained fire or emergency medical services agencies including: Airport Fire Department, Monroe County Haz-Mat and Special Operations and Monroe County Sheriff's Office Specialized Teams.

A request for qualifications was issued for these services with the University of Rochester the sole respondent.

The specific legislative action required is to authorize the County Executive, or his designee, to execute a contract, and any amendments thereto, with the University of Rochester, 601 Elmwood Avenue, Rochester, New York 14624, for a Monroe County Emergency Medical Services Medical Director in an amount not to exceed \$120,000, for the period of January 1, 2020 through December 31, 2020, with the option to renew for one (1) additional one-year term, in an amount not to exceed \$120,000 per year.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract is included in the 2020 operating budget of the Department of Public Safety, general fund 9001, funds center 2408020300, Emergency Medical Services and will be included in future years' budgets. No additional net County support is required in the current Monroe County budget.

The University of Rochester is a not for profit agency and the records in the Office of the Monroe County Treasury have indicated that it does not owe any delinquent Monroe County property taxes.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Acceptance of a Grant from the New York State Division of Criminal Justice Services for the

Finger Lakes Regional Youth Justice Team

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$250,000, for the Finger Lakes Regional Youth Justice Team (FLRYJT) for the period of April 1, 2019 through March 31, 2021.

The FLRYJT proposes to solidify cross-systems Juvenile Justice reform efforts through staff training, data collection, technical assistance and administrative support. The focus of these efforts will be increased collaboration across service sectors and increased capacity to service persons impacted by mental health issues and trauma. A collaborative input process determined that timely, appropriate response to young people in crisis because of a mental health problem or trauma is a universal need across the rural, urban and suburban communities served by the FLRYJT.

The grant will fund trauma informed collaboratives for the twelve county region and overtime and fringe benefits for Probation staff who will provide administrative support to the FLRYJT, fulfill the grant reporting requirements, issue Requests for Proposals, and reimburse the mileage expenses of FLRYJT members who attend meetings and training. The County will receive \$150,000 in year one and \$100,000 in year two. This is the second time the County has received this grant. This period of funding represents an increase of \$225,766 from the last grant cycle.

The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to accept a \$250,000 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Finger Lakes Regional Youth Justice Team, for the period of April 1, 2019 through March 31, 2021.
- 2. Amend the 2020 operating budget of the Department of Public Safety, Office of Probation and Community Corrections, by appropriating the sum of \$150,000 into general fund 9300, funds center 2403010000, Probation/Community Corrections Administration.

- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This grant is 100% funded by the New York State Division of Criminal Justice Services. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with SWBR Architecture, Engineering & Landscape Architecture, P.C., in the amount of \$177,581, for professional engineering services, and LeChase Construction Services, LLC, in the amount of \$109,525, for construction management services, for the Monroe Community College Finger Lakes Workforce Development Center Project.

The goal of the project is to support Monroe Community College (MCC) in its efforts to create a world-class Finger Lakes Workforce Development Center (FWDC) to serve the workforce and economic development needs of key areas in the region. This project will involve the design and renovation of existing vacant space adjacent to the MCC Downtown Campus to create the FWDC. The renovations will create new instructional and lab space in an open, industrial-like and multi-function space. The Center will establish the Region's first education pipeline to high-demand technical manufacturing jobs providing academic and industrial training. The project is estimated to cost \$11,400,000.

Several consultants were considered, with SWBR Architecture, Engineering & Landscape Architecture, P.C. and LeChase Construction Services, LLC rated the most qualified to provide these services.

SWBR Architecture, Engineering & Landscape Architecture, P.C. proposes to provide program planning and schematic design services in the amount of \$177,581. A cost breakdown of these services is as follows:

> Basic Design Services \$138,441 Special Services \$ 39,140 Total \$177,581

LeChase Construction Services, LLC proposes to provide construction management services through design and bidding in the amount of \$109,525.

The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to execute a contract with SWBR Architecture, Engineering & Landscape Architecture, P.C., 387 E. Main Street, Rochester, New York 14604, for professional engineering services, for the Monroe Community College Finger Lakes Workforce Development Center Project, in the amount of \$177,581, and any amendments necessary to complete the project within the total capital fund(s) appropriation.
- 2. Authorize the County Executive, or his designee, to execute a contract with LeChase Construction Services, LLC, 205 Indigo Creek Drive, Rochester, New York 14626, for construction management services, for the Monroe Community College Finger Lakes Workforce Development Center Project, in the amount of \$109,525, and any amendments necessary to complete the project within the total capital fund(s) appropriation.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for these contracts, consistent with authorized uses, is included in capital fund 1939 and any capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither SWBR Architecture, Engineering & Landscape Architecture, P.C., LeChase Construction Services, LLC, nor any of their principal officers, owe any delinquent Monroe County property taxes. I recommend that Your Honorable Body authorize an intermunicipal agreement with the New York State Department of Transportation for reimbursement to the County of appropriate costs relating to the operation and maintenance of the Colonel Patrick O'Rorke Bridge, in an amount not to exceed \$880,000, commencing on October 1, 2019 and ending September 30, 2021, with the option to renew for two (2) additional two-year terms upon mutual consent of both parties and with the approval of the New York State Attorney General's Office and the Office of the New York State Comptroller, in an amount not to exceed \$880,000 for each additional term.

As a result of jurisdictional transfers from Monroe County to New York State that were finalized on November 26, 2007, the New York State Department of Transportation has assumed jurisdictional responsibility for the Colonel Patrick O'Rorke Bridge and its highway approaches. Since that time, the State has utilized Monroe County's experience in the operation of the bridge and would like to continue to do so. Therefore, to assist in this effort, the Monroe County Department of Transportation will be responsible for the operation and maintenance of the Colonel Patrick O'Rorke Bridge on behalf of the New York State Department of Transportation and will be reimbursed 100% of the related costs. The term will be for 24 months and will coincide with the State fiscal year.

The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to execute an intermunicipal agreement, and any amendments thereto, with the New York State Department of Transportation for reimbursement to the County of appropriate costs relating to the operation and maintenance of the Colonel Patrick O'Rorke Bridge, in an amount not to exceed \$880,000, commencing on October 1, 2019 and ending September 30, 2021, with the option to renew for two (2) additional two-year terms upon mutual consent of both parties and with the approval of the New York State Attorney General's Office and the New York State Comptroller, in an amount not to exceed \$880,000 for each additional term.
- 2. Incorporate by reference and adopt the attached resolution required by New York State for the Operation and Maintenance of the Colonel Patrick O'Rorke Bridge Project.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this agreement is included in the 2020 operating budget of the Department of Transportation, road fund 9002, funds center 8005020000, O'Rorke Bridge Operations, and will be requested in future years' budgets. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

I recommend that Your Honorable Body amend Resolution 204 of 2019 to rescind Section 4 to incorporate by reference and adopt the attached resolution required by the New York State Department of Transportation for the Lake Road West Fork Bridge over Sandy Creek Project in the Town of Hamlin.

The Lake Road West Fork Bridge is County-owned and spans Sandy Creek in the Town of Hamlin. The project will involve preliminary engineering and final design for preventive maintenance to the bridge structure. The current total project estimate is \$846,000.

Major funding will be provided by Federal funds in the amount of approximately 95% of the project cost with overall project administration by Monroe County.

Monroe County was awarded Federal funding for this project through the Bridge NY program. New York State requires that construction of the project begin no later than twenty-four (24) months after award and that the construction phase of the project be completed within thirty (30) months.

Pursuant to Resolution 204 of 2019, Your Honorable Body incorporated and adopted a New York State resolution to secure Bridge NY funding for the project. The State Resolution stated incorrectly that the time period required for completing the project was three years. Under State law, the time period required for completing the project is two and one-half years (thirty months). Therefore, this action is intended to correct the time period required to complete the project. The other portions of Resolution 204 of 2019 shall remain the same.

The specific legislative action required is to amend Resolution 204 of 2019 to rescind Section 4 to incorporate by reference and adopt the attached resolution required by New York State for the Lake Road West Fork Bridge over Sandy Creek Project.

I recommend that Your Honorable Body amend the 2020 Capital Budget and Bond Resolution 52 of 2019 to provide an increase in funding for the Park Road Bridge over Irondequoit Creek Project in the Town of Perinton.

Your Honorable Body, through Bond Resolution 256 of 2017, authorized financing for the Park Road Bridge over Irondequoit Creek Project. The Project includes the removal of the existing Park Road Bridge including superstructure and substructures, replacement with 3-sided 35' span precast concrete bridge units and concrete wingwalls, widened shoulders, standard bridge railing, roadway reconstruction and asphalt paving of the road within the project limits. There are currently insufficient funds available for the project due to unforeseen underground conditions that were not anticipated at the time of project design and engineering. These conditions consisted of existing soils that were found to be unstable for footing excavation due to a higher than expected water table and running sand which required the addition of steel sheeting in order to safely excavate for the new bridge footing, as well as requiring significantly longer piles than expected. These factors caused an increase in estimated construction costs of \$165,000.

The specific legislative actions required are:

- 1. Amend the 2020 Capital Budget to increase funding for the Park Road Bridge over Irondequoit Creek Project in the Town of Perinton, in the amount of \$40,000 from \$1,190,000 to \$1,230,000, for a total project authorization of \$1,230,000.
- 2. Amend Bond Resolution 52 of 2019 to increase financing for the Park Road Bridge over Irondequoit Creek Project in the Town of Perinton, capital fund 1861, in the amount of \$40,000, from \$1,190,000 to \$1,230,000, for a total project authorization of \$1,230,000.
