FAMILY CAMPGROUND RULES

- Webster campground is open for family camping from May 1st through October 31st.
- Reservations can only be made for full weekends (Friday and Saturday), NO one night reservations on weekends. Minimum three-days on holidays (Friday, Saturday and Sunday) when holidays fall on a Monday.
- Campground check in will be conducted via phone call in order to comply with social distancing guidlines. Upon arriving at the campgrounds please call 585-872-5326 to check in with park staff.
- You must be at least 21 years of age to make a camping reservation and older and remain on the site during your stay.
- Cancellation policy must be made fourteen (14) days prior to arrival to request a refund minus fifteen (15) percent. If cancellation is less than fourteen (14) days, there will be no refund.
- The maximum length of stay at the campground is two weeks.
- Check-in at 2:00 pm. Check-out time is 1:00 pm or you will be charged for an extra day.
- Maximum of 6 campers and 2 vehicles per site. No more than four visitors are permitted and must leave by 10:00 pm.
- Quiet hours are enforced between 10:00 pm and 8:00 am.
- Children must be supervised at all times.
- For Emergencies call 911.
- Pets must be on a leash at all times and are not allowed in playgrounds or picnic areas. Owners are responsible for cleaning up after their pets.
- Hoses may be connected to water spigots only while refilling storage tanks. Do not wash dishes at spigots. Trailers must have a "t" or a "y" to hook hoses to spigot, as not to lock up water for other campers.
- All liquids and waste materials must be disposed of at the dumping station.
- Fires are allowed in fire rings and cooking grills only. Firewood is sold at Wolf Cabin, though dead wood on the grounds may be used.
- Sites must be left clean. Please do not burn garbage in the fire rings.
- No beer barrels or beer kegs are allowed in the campgrounds.
- Do not remove tables from campsites.
- Campground speed limit is 5mph. No riding bicycles around bathroom or shower areas. No pools or water slides in campground area.
- No washing of RVs or cars in campgrounds.
- If you are evicted from the campgrounds, no refund will be given.

SPECIAL COVID-19 RULES and INSTRUCTIONS 6/19/2020

Dial 911 for emergencies. Dial 872-5326 for non-emergency matters.

All campers must abide by the following guidance:

- Campers shall not congregate at another camper's site. No gatherings or parties of any kind are permitted.
- Only registered campers should be allowed into the campground. There should not be any outside visitors.
- All gatherings spaces (e.g. pavilions) are closed.
- Patrons must comply with CDC recommendations on social distancing.
- Patrons must wear a face covering in compliance with New York State guidelines if social distancing is not possible.

Additionally:

- Any camper that begins to feel ill with COVID-19 like symptoms shall self-isolate and contact their personal healthcare provider.
- Dogs must stay on a leash and remain away from others.
- Monroe County Parks department employees will monitor the campground to ensure compliance with these rules.
