# Irondequoit Bay Technical Staff Meeting Notes November 17, 2022

## Water Level Update

IJC reported levels:

Ontario Lake Current: 244.16 ft (Historical Average: 244.62 ft)

Outflow: 6,530 cubic meters / second (Historical Average: 7,320 cubic meters / second)

Supply: 6,220 cubic meters/second (Average: 6,940 cubic meters/second)

#### Local Observations:

- Water is VERY low; Last time we saw this level was 2017; boats pulled out early and opted to use public launch to take their boats out of the bay (Mayer Marina)
- Boats came out of the water early even though the weather is/was still decent
