ACTION ITEMS:

a) Amend the 2025 Capital Budget to increase funding for the project entitled "Construction of a 9/11 First Responders Memorial at Highland Park" by \$144,000, from \$350,000 to a total project authorization of \$494,000 and to decrease funding for the project entitled "Buildings and Structures" by \$144,000, from \$4,300,000 to \$4,156,000, for a total project authorization of \$4,156,000.

Presenter: Robert Kiley, Parks Department

Discussion: Mr. Kiley explained the Parks Department received six bids for construction of the Highland Park First Responders 9/11 Memorial. The lowest bidder was the selected bid by CP Ward, in the amount of \$442,744. This was higher than the engineer's estimate of \$331,000 in the budget. To make up the deficit they would like to transfer \$144,000 from the Buildings and Structures fund to this capital project for the construction of the memorial.

Mr. Kiley provided the below information in response to questions from the Board:

- Bids ranged from \$442,744 to \$895,000.
- The original engineer's estimate was in the spring 2025
- The Buildings and Structures Capital Fund is a cash capital account for a variety of maintenance efforts. At this time there is not a concern with projects being postponed due to this transfer.
- There is no net change, Parks is only moving funds from one account to another.
