ANNOUNCES LIVE AND VIRTUAL SESSIONS FOR FALL 2022!

The Monroe County Department of Planning & Development will host one in-person training on November 3rd and has partnered with the Genesee Finger Lakes Regional Planning Council (<u>G/FLRPC</u>) and the Nine-Counties of the Genesee Finger Lakes Region to host five virtual trainings over three days throughout November. All trainings will be two hours each and four hours of training will satisfy New York State's four-hour annual training requirement for members of Municipal Planning Boards and Zoning Boards of Appeals. Code Enforcement Officers and Building Officials are also eligible for training credits for several trainings. Introduction to New York State Environmental Quality Review (SEQR)

Thursday, November 3 — 5:00 to 7:15 P.M.

This in-person session will focus on the fundamentals of SEQR, an overview of process, roles and responsibilities of boards and applicants, substantive and procedural information, and salient legal precedents.
