MCSO K-9 DOYLE AND HANDLER DEPUTY VETERE MAKE PROMOTING PRISON CONTRABANDARREST IN MONROE COUNTY JAIL

Inmate Martin Wall Charged

Rochester, NY (**March 15, 2019**) – On Wednesday, March 13, 2019, at 12:15 p.m., shortly after being booked on a Criminal Possession of a Weapon in the 3rd degree (Class D-Felony) charge in the Monroe County Jail, inmate Martin Wall, 35, Rochester, was suspected to be in possession of marijuana.

Monroe County Sheriff's Deputy Robert Vetere conducted a K-9 search with Doyle in the booking area of the jail where Mr. Wall was located. Doyle immediately alerted to Wall. During a search of Mr. Wall, conducted in a booking cell, Wall handed deputies two plastic bags containing a substance that tested positive for marijuana. As a result, deputies charged Wall with Promoting Prison Contraband in the 2nd degree (Class A – Misdemeanor) and Unlawful Possession of Marijuana (Violation).

"K-9 Doyle and his handler, Deputy Robert Vetere, continue to do diligent police work inside of the Monroe County Jail and Monroe Correctional Facility, proven yet again with this latest arrest," said Monroe County Sheriff Todd K.

Baxter. "We will not tolerate the smuggling of drugs into our detention facilities and will charge anyone who is believed to be doing so, to the fullest extent of the law. When you bring drugs into the Monroe County Jail or Monroe Correctional Facility, you will be charged with Promoting Prison Contraband. Thank you to Deputy Vetere and K-9 Doyle for your exceptional police work."

Since K-9 Doyle and Deputy Vetere began their detail in the Monroe County Jail and Monroe Correctional Facility (January 2019 – Present), deputies Doyle and Vetere are credited with the following:
