MONROE COUNTY SHERIFF'S DEPUTIES ARREST TWO ROCHESTER MEN FOR 'SMASH AND GRAB' AT PITTSFORD JEWELRY STORE

Suspects Stole More Than \$200,000 Worth of Jewelry

Pittsford, NY (October 23, 2019) – Monroe County Sheriff's deputies arrested two men in connection with a burglary that occurred on April 27, 2019 at The Source Fine Jewelers, located at 3300 Monroe Ave., Pittsford. On October 15, 2019, after a lengthy investigation, and with the assistance of the MCSO Warrant Unit, MCSO deputies arrested Naquan J. White, 23, Rochester, and charged him with Grand Larceny 2nd, Burglary 3rd and Criminal Mischief 2nd. On October 21, 2019, MCSO deputies arrested the second suspect, Alphonso Bouie Jr., 25, Rochester, and charged him with Grand Larceny 2nd, Burglary 3rd and Criminal Mischief 2nd.

The investigation revealed that on April 27, 2019 at 3:34 a.m., White entered The Source Fine Jewelers by smashing one of the front plate glass windows with what appeared to be a sledgehammer. Once inside, White smashed three (3) jewelry cases and began to fill his pockets





with trays of jewelry before handing jewelry to Bouie, who was waiting outside. Bouie and White fled the area by car in an unknown direction.

The investigation further determined that the retail value of the stolen jewelry was between \$212,000 and \$250,000. Damages to the front window and jewelry cases were in excess of \$6,000.00.

White was arraigned in Pittsford Town Court and remanded to the Monroe County Jail on \$10,000/\$15,000 bail/bond. Bouie was subsequently arraigned in Pittsford Town Court and remanded to the Monroe County Jail on \$10,000/\$20,000 bail/bond.
