## MCSO COURT DEPUTY NAMED 2018 COURT OFFICER OF THE YEAR: NYS SHERIFFS' INSTITUTE

**Rochester, NY (January 22, 2019)** – Today, January 22, 2019, the New York State Sheriffs' Institute named Monroe County Sheriff's Deputy Jeffrey Ingham 'Court Officer of the Year' at the New York State Sheriffs' Association Winter Conference in Albany, NY. Deputy Ingham is recognized for his professionalism and expertise as a dedicated deputy and respected instructor, holding certifications in multiple fields, including Defensive Tactics, Taser, Firearms, Advanced Firearms, and Advanced Reality-Based Training.

Deputy Ingham began his career with the Monroe County Sheriff's Office in 1994, employed as a trainee while in college. After college, he worked for the MCSO Property Clerk, as well as the Quartermaster. In 1998, Deputy Ingham was hired as a sworn deputy in the Court Bureau and attended the Academy. For more than 20 years, Deputy Ingham has devoted his career to the Sheriff's Office and the citizens of Monroe County, giving back to others while on duty and at outside venues upon request.



Deputy Ingham became a General Topics instructor in 2003. He attended the Tony Blauer Instruction School in 2009, becoming a Glock Armorer. In 2012, Deputy Ingham became an instructor evaluator, instructing recruits at numerous academies. In addition, Deputy Ingham has taught in many in-service capacities. Adding to his resume, Deputy Ingham is also the Taser Coordinator, responsible for keeping Tasers functioning and instructing annual certification.
