UPDATE: Bank Robbery Suspect Arrested Thanks to a Team Effort Between Multiple Police Agencies

Pittsford, NY (May 16, 2019) — On May 14th, 2019 The Monroe County Sheriff's Office, in collaboration with Brighton Police, Gates Police, Greece Police, Rochester Police, and the New York State Police made an arrest of a bank robbery suspect that led police on a car chase throughout the county. After investigating the incident, Jason S. Rosso, 40, Rochester, was arrested and charged with Robbery 3rd (NYSPL 160.05, a class D Felony) in relation to a bank robbery at the M & T Bank located at 3290 Monroe Avenue, Pittsford. Rosso was arraigned in Pittsford Town Court and remanded to the Monroe County Jail without bail by Judge Bernacki.

Background:

On May 14th, 2019 at 1:51 p.m., MCSO responded to M & T Bank, 3290 Monroe Ave., for a robbery in progress. The suspect, later identified as Jason S. Rosso, passed a note to the bank teller. Rosso fled the scene in a vehicle with an undisclosed amount of money.





MCSO Sergeant Shawn Edwards described the suspect's vehicle on air, and Gates Police Sergeant David Kaiser heard the description and spotted the vehicle on Mt. Read Boulevard in the City of Rochester. Sergeant Kaiser initiated a traffic stop; however, the vehicle fled and a pursuit ensued. The vehicle was pursued through numerous jurisdictions throughout the county and ended in Winton Place Plaza on Winton Rd., Brighton, where Rosso's vehicle crashed.

Rosso was detained by police on scene and turned over to the Monroe County Sheriff's Office for questioning. He was transported to the hospital with minor injuries and has since been released from the hospital. Rosso was arraigned in Pittsford Town Court and remanded to the Monroe County Jail without bail.
