**Henrietta, NY- (June 25, 2020)** - On Wednesday June 24, 2020 at 3:36 pm, the Monroe County Sheriff's Office Tactical Unit attempted to stop a vehicle on Lehigh Station Road near Route 390 in the Town of Henrietta that was believed to be occupied by an individual with multiple outstanding warrants, who was also wanted by the Rochester Police Department. When deputies attempted to stop the vehicle, the vehicle fled and nearly struck a police vehicle and a deputy. The vehicle failed to stop for deputies and the decision was made not to pursue. A short time later, it was discovered that the vehicle crashed in the area of Route 390 near Hylan Drive and two occupants fled from the vehicle. After a short foot pursuit that ended on the railroad tracks near Calkins Road, two people were arrested on multiple outstanding warrants.

MCSO deputies charged Joshua Rivera 26, Penfield with Unlawful Fleeing a Police Officer in a Motor Vehicle 3<sup>rd</sup> Degree (Class-A Misdemeanor), Reckless Endangerment 2<sup>nd</sup> (Class-A Misdemeanor), Resisting Arrest (Class-A Misdemeanor), Reckless Driving (Misdemeanor) along with additional Vehicle and Traffic Violations. Rivera was turned over to RPD on outstanding Burglary/Petit Larceny charges. Once Rivera was taken to Monroe County Jail, MCSO lodged the above charges against him along with four Monroe County Court warrants. MCSO also arrested Megan Quigley 22, Fairport, on a warrant from the Town of Perinton Court. Quigley also has warrants with RPD and Macedon PD. Quigley was released on an appearance ticket on her MCSO warrant then turned over to RPD for an outstanding warrant.
