## Monroe County Sheriff's Deputies Thwart a Burglary in Progress by Three Rochester Men in the Town of Parma

*Investigation Led to Suspects' Arrests in Pittsford Burglaries*

**Parma, NY (August 9, 2019)** — On August 5<sup>th</sup>, 2019, The Monroe County Sheriff's Office arrested three men; Deyshawn Bice, 22, Rochester, Jared Sampson, 21, Rochester, and Terrance Jones, Jr., 23, Rochester, in connection with vehicle larcenies on Fallwood Terrace in Parma, NY. Deputies responded to Fallwood Terrace on the above date at around 2:30 a.m. after an area resident reported witnessing several unknown men engaged in suspicious activity outside of his home.

Deputy Eric Hayes was the first deputy to arrive on location. When he approached the scene on foot, Deputy Hayes observed multiple males standing behind one of the homes. Deputy Hayes witnessed one of the men open the swing door of the attached garage of the home. As the males were about to enter the garage, they became aware of Deputy Hayes and the suspects fled the scene on foot. Deputy Hayes broadcast the information on his radio and a foot chase ensued.

Multiple MCSO units responded to the area and took perimeter points. The Rochester Police Department's K-9 also responded to assist with the search. As Deputy Hayes continued the search on foot, he attempted to conduct a vehicle stop on a car travelling down Fallwood, but the driver of the vehicle hit the gas and sped by Deputy Hayes, nearly hitting him. Deputy Hayes broadcast the vehicle's description, and as a result, Deputy Christopher Santillo spotted and successfully stopped the vehicle at the intersection of Summertime Trail and Fallwood Terrace. The three men in the vehicle were taken into custody by multiple deputies on scene.

All three (3) suspects were arraigned in Parma Town Court on August 5, 2019 on the following charges:

- ❖ 1 Count of Attempted Burglary in the 2<sup>nd</sup> degree
- ❖ 1 Count of Attempted Petit Larceny

Jones was also charged with Reckless Endangerment in the 1<sup>st</sup> degree for nearly striking Dep. Hayes with his vehicle. Additional charges from Parma are forthcoming.

Further investigation revealed the same three men were wanted for questioning from home burglaries that occurred in the overnight hours of August 2, 2019 on Silco Drive, Pittsford. The suspects burglarized three (3) homes and attempted to burglarize an additional two (2) homes on Silco Drive. As a result, search warrants were issued and executed for the suspects' homes.

The suspects were found to have stolen all of the following items from three (3) homes in Pittsford, which have since been recovered:

- 2 Rings valued at \$8,000 total
- 8 credit cards
- 1 MacBook
- 1 Projector
- 1 Television

Bice, Sampson, and Jones were arraigned in Pittsford Town Court on August 8, 2019 on the following charges:

- 3 Counts of Burglary 2nd (C Felony)
- 2 Counts of Attempted Burglary 2nd (D Felony)
- 1 Count of Grand Larceny 3rd (D Felony)
- 8 Counts of Grand Larceny 4th (E Felony)
- 1 Count of Falsifying Business Records 1st (E Felony)
- 2 Counts of Petit Larceny (A Misdemeanor)
- 1 Count of Criminal Mischief 4th (A Misdemeanor)
- 1 Count of Attempted Petit Larceny (B Misdemeanor)



The suspects are currently being held in the Monroe County Jail. Bice is held on \$15,000 bail/\$25,000 bond, Sampson is held on \$12,500 bail / \$17,000 bond, and Jones is being held without bail.
