Henrietta, NY (June 24, 2020) – On Wednesday, June 10, 2020, Monroe County Sheriff's deputies responded to the area of 100 Brittany Lane, Pittsford, for the report of a female passed out in a vehicle. Deputies observed multiple hypodermic needles, glassine baggies, credit cards, and other property associated with vehicle larcenies inside the vehicle. Through investigation, deputies identified the female as Samantha Wroblewski, 31, Oakfield, NY. A male in the vehicle initially identified himself to deputies as Lawrence Waters, 28, Oakfield, NY, but did not provide identification. Through investigation, deputies later determined Waters' identity to be Judd Farewell, 28, Oakfield. Both Wroblewski and Farewell admitted to committing numerous car larcenies throughout Monroe County. Deputies charged both with one count of Criminal Possession of Stolen Property 4th degree (Class E- Felony) and one count of Criminal Possession of Stolen Property 5th degree (Class A – Misdemeanor). Both Wroblewski and Farewell were arraigned and released on appearance tickets.

On Saturday, June 13, 2020, at 10:00 a.m., Monroe County Sheriff's deputies initiated a traffic stop on a pickup truck at Walmart, located at 1200 Miracle Mile Dr., Henrietta. While speaking to the driver, who identified himself as Lawrence Waters, deputies observed several hypodermic needles and multiple credit cards inside the truck. Deputies later identified Waters as Judd Farewell.

Upon further investigation, it was determined Mr. Farewell broke into three vehicles days prior; June 8 - 9, 2020 on Campus Dr., Henrietta and two break-ins June 10 – 11, 2020 on Cave Hollow Dr., Henrietta. Deputies recovered stolen credit cards from the aforementioned vehicle break-ins from Mr. Farewell's truck.

Deputies charged Farewell with three (3) counts Criminal Possession of Stolen Property 4th degree (Class – E Felony) and one count Criminal Impersonation (Class – A Misdemeanor).

Since Mr. Farewell's arrest on June 13, 2020, deputies filed additional charges to include 2 counts of Criminal



Possession of Stolen Property, 4th degree (Class E – Felony) for possession of a stolen vehicle and credit cards, as well as several vehicle and traffic violations.

Farewell was remanded to the Monroe County Jail pending arraignment. Following arraignment by Judge Ruhlman, Farewell was released on his own recognizance and turned over to the Genesee County Sheriff’s Office for arraignment on an outstanding warrant in Genesee County. Farewell was remanded to the Genesee County Jail where he is being held on \$5,000/\$10,000 cash/bail.

The investigation is ongoing and additional charges may be filed. MCSO Deputies D. Smith, Englebrecht, and Winner are credited with good police work.
