Pittsford, NY- (September 15, 2020) - On Saturday September 12, 2020 at 3:39 a.m., MCSO A Zone deputies responded to an address in Pittsford for the report of a burglary in progress in an occupied residence. The homeowner was awakened by the sound of glass breaking and called 911 to report a strange man in the residence with a flashlight. Deputies arrived on scene and immediately apprehended two suspects in the garage and discovered two others fleeing back into the house. Deputies pursued those suspects and were able to take a third suspect, Jalen Morris, into custody after he jumped from an upstairs window, injuring himself. The fourth suspect was able to escape through the backyard. The investigation into that person's identity is underway. Fortunately the homeowner was not injured.

MCSO deputies charged Paul Sylve (43, Rochester), Patience Jones (26, Rochester) and Jalen Morris (27, Rochester) with: Burglary 2nd (Class-C Felony), Criminal Mischief 4th (Class-A Misdemeanor) and Petit Larceny (Class-A Misdemeanor). All three suspects were remanded to the Monroe County Jail per a Town of Pittsford judge. At the time of their arrest, the suspects also had outstanding warrants for other charges.

This investigation is ongoing and a search warrant conducted on the suspects' vehicle uncovered stolen property from other burglaries across our region. Additional charges are expected.
