TITLE: BEHAVIORAL HEALTH NURSE

## JOB SUMMARY:

This is a professional nursing position, located at Monroe Community Hospital, responsible for the development and implementation of procedures regarding behavioral health. Duties involve advanced professional nursing techniques and treatments for behaviorally complex patients and residents, for which this position will provide training to other nursing staff. The employee reports directly to, and works under the general supervision of the Nursing Administrator or other higher-level staff member with wide latitude allowed for independent judgment and decision making. Does related work as required.

## PROPOSED QUALIFICATIONS:

Possession of a New York State License as a Registered Professional Nurse plus one (1) year paid full-time or its part-time equivalent experience as a Registered Nurse, six (6) months of which must have been working with people who have mental or behavioral health issues or intellectual or developmental disabilities.

**NOTE:** Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. ### **SPECIAL REQUIREMENTS:**

Possession of a valid New York State Registered Nurse (RN) License.

This position is subject to a background check for criminal convictions. Convictions will be considered but will not automatically disqualify the candidate. No criminal background check will occur until after a conditional offer of employment has been made, unless required prior to a conditional offer because of the nature of the position or otherwise required by law.

Candidates for employment with Monroe County Government will be required to pass a pre-employment drug test. Failure to meet the standards may result in disqualification.

If you are appointed, you will be required to possess a valid license to operate a motor vehicle in New York State or otherwise demonstrate your capacity to meet the transportation needs of the position.
